14	Be it enacted by the Legislature of the state of Utah:
15	Section 1. Section 41-1a-408 is amended to read:
16	41-1a-408. Special group plates Design Application Issuance.
17	(1) As used in this section:
18	(a) "Collegiate license plates" means the special group license plates issued under this
19	section to a contributor to an institution after payment of the appropriate fees.
20	(b) (i) "Contributor" means a person who has donated or in whose name at least \$25 has
21	been donated to:
22	(A) a scholastic scholarship fund of a single institution;
23	(B) the Office of Veterans' Affairs in the Department of Community and Economic
24	Development for veterans' programs; [or]
25	(C) the Division of Wildlife Resources for conservation of wildlife and the enhancement,
26	preservation, protection, access, and management of wildlife habitat[-]; or
27	(D) the Department of Agriculture and Food for the benefit of soil conservation districts.

1	(ii) Except as provided under Subsection (13), the donation must be made in the 12 months
2	prior to registration or renewal of registration.
3	(c) "Institution" means a state institution of higher education or a private institution of
4	higher education in the state accredited by a regional or national accrediting agency recognized
5	by the United States Department of Education.
6	(d) "Soil conservation license plates" means the special group license plates issued under
7	this section to a contributor to the Department of Agriculture and Food after payment of the
8	appropriate fees.
9	[(d)] (e) "State institution of higher education" has the same meaning as provided in
10	Section 53B-3-102.
11	[(e)] (f) "Veterans' license plates" means the special group license plates issued under this
12	section to a contributor to the Office of Veterans' Affairs after payment of the appropriate fees.

15	(2) (a) The design and maximum number of numerals or characters on special group
16	license plates shall be determined by the division in accordance with the criteria in Subsection
17	(2)(b).
18	(b) Except for Olympic special group license plates, each special group license plate shall
19	display:
20	(i) the word Utah;
21	(ii) the name or identifying slogan of the special group;
22	(iii) a symbol not exceeding two positions in size representing the special group; and
23	(iv) the combination of letters, numbers, or both uniquely identifying the registered
24	vehicle.
25	(3) (a) The division shall, after consultation with a representative designated by the special
26	group, specify the word or words comprising the special group name and the symbol to be
27	displayed upon the special group license plates.
28	(b) Collegiate, veterans', soil conservation, and wildlife license plates may not be
29	redesigned under this section more frequently than every five years.
30	(c) Veterans' license plates shall display one of the symbols representing the Army, Navy,
31	Air Force, Marines, or Coast Guard.

1	(4) Subject to Subsections (10) and (12), the division shall only issue special group license
2	plates to a person who is:
3	(a) a current member of the Legislature;
4	(b) a current member of the United States Congress;
5	(c) a survivor of the Japanese attack on Pearl Harbor;
6	(d) a former prisoner of war;
7	(e) a recipient of a Purple Heart, as provided in Section 41-1a-409;
8	(f) a current member of the National Guard;
9	(g) a person with a disability or the registered owner of a vehicle that an organization uses
10	primarily for the transportation of persons with disabilities that limit or impair the ability to walk;
11	(h) a contributor to an institution's scholastic scholarship fund;
12	(i) a contributor to the Division of Wildlife Resources;
13	(j) a contributor to the Office of Veterans' Affairs;
14	(k) licensing a special interest vehicle;
15	(l) licensing a vintage vehicle;
16	(m) a licensed amateur radio operator;
17	(n) registering a farm truck; [or]
18	(o) a currently employed, volunteer, or retired firefighter[-]; or
19	(p) a contributor to the Department of Agriculture and Food.
20	(5) (a) A vehicle displaying a survivor of the Japanese attack on Pearl Harbor license plate
21	decal, a former prisoner of war license plate decal, or a Purple Heart license plate decal shall be
22	titled in the name of the veteran or the veteran and spouse.
23	(b) Upon the death of the veteran, the surviving spouse may, upon application to the
24	division, retain the special group license plate decal so long as the surviving spouse remains
25	unmarried.
26	(c) The division shall require the surviving spouse to make a sworn statement that the
27	surviving spouse is unmarried before renewing the registration under this section.
28	(6) (a) (i) In accordance with rules made under Subsection (12), the division shall issue
29	a person with a disability special group license plate, temporary removable windshield placard,
30	or a removable windshield placard to:
31	(A) a qualifying person with a disability; or

1	(B) an organization that uses a vehicle registered in the applicant's name primarily for the
2	transportation of persons with disabilities that limit or impair the ability to walk.
3	(ii) The division shall issue a person with a disability special group license plate or a
4	removable windshield placard to a person with a permanent disability.
5	(iii) The issuance of a person with a disability special group license plate does not preclude
6	the issuance to the same applicant of a removable windshield placard.
7	(iv) The division shall issue on request one additional placard to a person with a person
8	with a disability special group license plate, temporary removable windshield placard, or a
9	removable windshield placard.
10	(b) The temporary removable windshield placard or removable windshield placard shall
11	be hung from the front windshield rearview mirror when the vehicle is parked in a parking space
12	reserved for persons with disabilities so that it is visible from the front and rear of the vehicle.
13	(7) (a) An applicant for original or renewal collegiate license plates must be a contributor
14	to the institution named in the application and present the original contribution verification form
15	to the division at the time of application.
16	(b) An institution with a special group license plate shall issue to a contributor a
17	verification form designed by the commission containing:
18	(i) the name of the contributor;
19	(ii) the institution to which a donation was made;
20	(iii) the date of the donation; and
21	(iv) an attestation that the donation was for a scholastic scholarship.
22	(c) The state auditor may audit each institution to verify that the moneys collected by the
23	institutions from contributors are used for scholastic scholarships.
24	(d) After an applicant has been issued collegiate license plates or renewal decals, the
25	commission shall charge the institution whose plate was issued, a fee determined in accordance
26	with Section 63-38-3.2 for management and administrative expenses incurred in issuing and
27	renewing the collegiate license plates.
28	(8) (a) An applicant for original or renewal wildlife license plates must be a contributor
29	to the Division of Wildlife Resources.
30	(b) This contribution shall be:
31	(i) collected by the division;

2	motor vehicle registration fee; and
3	(iii) deposited into the Wildlife Resources Account created in Section 23-14-13, less actual

5	(9) The division shall issue Olympic special group license plates.
6	(10) (a) An organization that makes a significant contribution to the state may request the
7	commission to authorize special group license plates for the organization if the organization
8	collects a minimum of 500 applications with the fees required under Section 41-1a-1211.
9	(b) If the commission approves the request, the division shall design a license plate in
10	accordance with Subsections (2) and (3).
11	(c) If the commission rejects the request, the organization shall refund all fees to the
12	applicants.
13	(11) Any person who meets the criteria established under this part for issuance of special
14	group license plates may make application in the same manner provided in Sections 41-1a-410 and
15	41-1a-411 for personalized special group license plates.
16	(12) (a) The commission shall make rules in accordance with Title 63, Chapter 46a, Utah
17	Administrative Rulemaking Act, to:
18	(i) establish qualifying criteria for persons to receive, renew, or surrender special group
19	license plates, a temporary removable windshield placard, or a removable windshield placard;
20	(ii) establish the maximum number of numerals or characters for special group license
21	plates; and
22	(iii) require all temporary removable windshield placards and removable windshield
23	placards to include:
24	(A) an identification number;
25	(B) an expiration date not to exceed six months for a temporary removable windshield
26	placard and one year for a removable windshield placard; and
27	(C) the seal or other identifying mark of the division.
28	(b) The qualifying criteria under Subsection (12)(a) for a person with a disability special
29	group license plate, temporary removable windshield placard, or removable windshield placard
30	shall include a requirement that an initial application of a person with a disability be accompanied
31	by the certification of a licensed physician:

2	the ability to walk as defined in the federal Uniform System for Handicapped Parking, 58 Fed.

5	disability, not to exceed six months in the case of a temporary disability.
6	(13) (a) [Beginning January 1, 1997, the] The division may issue original veterans' license
7	plates.
8	(b) An applicant for original veterans' license plates must be at least a one-time contributor
9	to the Office of Veterans' Affairs.
10	(c) This contribution shall be:
11	(i) collected by the division;
12	(ii) treated as a voluntary contribution for the Office of Veterans' Affairs and not as a
13	motor vehicle registration fee; and
14	(iii) transferred to the Office of Veterans' Affairs at least monthly, less actual production
15	and administrative costs associated with making and issuing veterans' license plates.
16	(14) (a) Beginning January 1, 1999, the division may issue original soil conservation
17	license plates.
18	(b) An applicant for original soil conservation license plates must be a contributor to the
19	Department of Agriculture and Food.
20	(c) This contribution shall be:
21	(i) collected by the division;
22	(ii) treated as a voluntary contribution for the Department of Agriculture and Food for the
23	benefit of soil conservation districts and not as a motor vehicle registration fee; and

29	(1) All fees received and collected under this part shall be transmitted daily to the state
30	treasurer.

2	Transportation Fund.

1	(1) A license plate fee of \$5 per set shall be paid to the division for the issuance of any
2	new license plate under Part 4, License Plates and Registration Indicia, except for license plates
3	issued under Sections 41-1a-407 and 41-1a-417. The license plate fee shall be deposited as
4	follows:
5	(a) \$4 as provided in Section 41-1a-1201; and
6	(b) \$1 in the Transportation Fund.
7	(2) An applicant for original issuance of personalized license plates issued under Section
8	41-1a-410 shall pay a \$50 per set license plate application fee in addition to the fee required in

(7) A fee of \$5 shall be paid to the division for the replacement of any license plate issued 8 under Part 4, License Plates and Registration Indicia. The license plate fee shall be deposited as 9 follows:

10 (a) \$4 as provided in Section 41-1a-1201; and

11 (b) \$1 in the Transportation Fund.

12 (8) The division may charge a fee established under Section 63-38-3.2 to recover its costs 13 for the replacement of decals issued under Section 41-1a-408.

14 (9) The division may charge a fee established under Section 63-38-3.2 to recover the cost of issuing stickers under Section 41-1a-416. 15

16 (10) In addition to any other fees required by this section, the division shall assess a fee established under Section 63-38-3.2 to cover postage expenses if new or replacement license plates 17 18 are mailed to the applicant.

19 (11) The fees required under this section are separate from and in addition to registration fees required under Section 41-1a-1206. 20

21 (12) For vehicles with registration years expiring on or before June 30, 2002, applicants for original Olympic special group license plates or renewal of registration with Olympic special 22 23 group license plates shall pay the fees required under Section 41-1a-417.
