AN ACT RELATING TO WILDLIFE RESOURCES; ELIMINATING THE REQUIREMENT
TO OBTAIN A SMALL GAME LICENSE TO § ~~HUNT~~ TAKE § COUGAR OR BEAR; **h** AND MAKING
TECHNICAL AMENDMENTS; h AND
PROVIDING AN EFFECTIVE DATE.

- 15bc (19) (a) "Guide" means a person who receives compensation or advertises services for

- 15bi (21) "Hunting" means to take or pursue a reptile, amphibian, bird, or mammal by any means.
