6	AN ACT RELATING TO CRIMINAL LAW AND PUBLIC SAFETY; AMENDING THE
7	RECORDS REQUIREMENTS REGARDING THE CONTROLLED SUBSTANCE
8	DATABASE.
9	This act affects sections of Utah Code Annotated 1953 as follows:
10	AMENDS:
11	58-37-7.5, as last amended by Chapter 13, Laws of Utah 1998
12	Be it enacted by the Legislature of the state of Utah:
13	Section 1. Section 58-37-7.5 is amended to read:
14	58-37-7.5. Controlled Substance Database Advisory committee Pharmacy
15	reporting requirements Access Penalties.
16	(1) As used in this section:
17	(a) "Committee" means the Controlled Substance Database Advisory Committee created
18	in this section.
19	(b) "Database" means the controlled substance database created in this section.
20	(c) "Database manager" means the person responsible for operating the database, or his
21	designee.
22	(d) "Division" means the Division of Occupational and Professional Licensing created in
23	Section 58-1-103.
24	(e) "Drug outlet" has the same definition as in Section 58-17a-102.
25	(f) "Health care facility" has the same definition as in Section 26-21-2.
26	(2) (a) There is created within the division a controlled substance database.
27	(b) The division shall administer and direct the functioning of the database in accordance

with this section. The division may under state procurement laws contract with another state agency or private entity to establish, operate, or maintain the database. The division in collaboration with the board shall determine whether to operate the database within the division or contract with another entity to operate the database, based on an analysis of costs and benefits.

- (c) The purpose of the database is to contain data as described in this section regarding every prescription for a controlled substance dispensed in the state to any person other than an inpatient in a licensed health care facility.
- (d) Data required by this section shall be submitted in compliance with this section to the manager of the database by the pharmacist in charge of the drug outlet where the controlled substance is dispensed.
- (3) (a) There is created the Controlled Substance Database Advisory Committee. The committee members are:
 - (i) two members representing the Utah Medical Association;
 - (ii) one member representing the Utah Dental Association;

- 42 (iii) two members representing the Utah Pharmaceutical Association;
 - (iv) one member representing the Department of Public Safety;
- (v) one member representing the Utah Association of Chiefs of Police;
 - (vi) one member representing the Utah Sheriffs Association;
- 46 (vii) one member representing the state Office of the Attorney General;
 - (viii) one member representing the Statewide Association of Public Attorneys; and
- 48 (ix) three members representing the general public, and who are not health care providers.
- 49 (b) The committee shall be appointed and serve in accordance with Section 58-1-201.
- 50 (c) The committee shall advise the division regarding:
 - (i) establishing, maintaining, and operating the database;
 - (ii) access to the database and how access is obtained; and
- (iii) control of information contained in the database.
 - (4) The pharmacist in charge shall, regarding each controlled substance dispensed by a pharmacist under his supervision other than those dispensed for an inpatient at a health care facility, submit to the manager of the database the following information, by a procedure and in a format established by the division:
 - (a) name of the prescribing practitioner;

72	(5) The division shall maintain the database in an electronic file or by other means

75	(b) practitioners prescribing controlled substances in an unprofessional or unlawful
76	manner;
77	(c) individuals receiving prescriptions for controlled substances from licensed
78	practitioners, and who subsequently obtain dispensed controlled substances from a drug outlet in
79	quantities or with a frequency inconsistent with generally recognized standards of dosage for that
80	controlled substance; and
81	(d) individuals presenting forged or otherwise false or altered prescriptions for controlled
82	substances to a drug outlet.
83	(6) (a) The division shall by rule establish the electronic format in which the information
84	required under this section shall be submitted to the administrator of the database.
85	(b) The division shall ensure the database system records and maintains for reference:
86	(i) (A) identification of each person who requests information from the database;
87	[(ii)] (B) the information provided to the requesting person regarding each request; and
88	[(iii)] (C) the date and time of each request[-]; and
89	(ii) (A) the identification of each person who receives information from the database

91	(B) the information provided to that person; and
92	(C) the date and time this information is provided.
93	(7) The division shall make rules in collaboration with the committee to:
94	(a) effectively enforce the limitations on access to the database as described in Subsection
95	(8); and
96	(b) establish standards and procedures to ensure accurate identification of individuals
97	requesting information or receiving information without request from the database.
98	(8) The manager of the database shall make information in the database available only to
99	the following persons, and in accordance with the limitations stated and division rules:
100	(a) personnel of the division specifically assigned to conduct investigations related to
101	controlled substances laws under the jurisdiction of the division;
102	(b) authorized division personnel engaged in analysis of controlled substance prescription
103	information as a part of the assigned duties and responsibilities of their employment;
104	(c) a licensed practitioner having authority to prescribe controlled substances, to the extent
105	the information [requested] relates specifically to a current patient of the practitioner, to whom the
106	practitioner is prescribing or considering prescribing any controlled substance;
107	(d) a licensed pharmacist having authority to dispense controlled substances to the extent
108	the information [requested] relates specifically to a current patient to whom that pharmacist is
109	dispensing or considering dispensing any controlled substance;
110	(e) federal, state, and local law enforcement authorities engaged as a specified duty of their
111	employment in enforcing laws regulating controlled substances; and
112	(f) an individual who is the recipient of a controlled substance prescription entered into
113	the database, upon providing evidence satisfactory to the database manager that the individual
114	requesting the information is in fact the person about whom the data entry was made.
115	(9) The manager of the database may on his own initiative provide specific information
116	that is in the database to licensed practitioners under Subsection (8)(c) if the manager has
117	reasonable cause to believe that the information:
118	(a) identifies a situation described under Subsection (5)(b), (c), or (d); and
119	(b) the situation relates specifically to a current patient of the practitioner, to whom the

practitioner is prescribing or is considering prescribing any controlled substance.

121 [(9)] (10) Any person who knowingly and intentionally releases any information in the 122 database in violation of the limitations under [Subsection] Subsections (8) and (9) is guilty of a 123 third degree felony. 124 [(10)] (11) Any person who obtains or attempts to obtain information from the database 125 by misrepresentation or fraud is guilty of a third degree felony. 126 [(11)] (12) (a) A person may not knowingly and intentionally use, release, publish, or 127 otherwise make available to any other person or entity any information obtained from the database 128 for any purpose other than those specified in [Subsection] Subsections (8) and (9). Each separate 129 violation of this subsection is a third degree felony and is also subject to a civil penalty not to 130 exceed \$5,000. 131 (b) The procedure for determining a civil violation of this subsection shall be in 132 accordance with Section 58-1-108, regarding adjudicative proceedings within the division. 133 (c) Civil penalties assessed under this subsection shall be deposited in the General Fund. 134 [(12)] (13) (a) The failure of a pharmacist in charge to submit information to the database 135 as required under this section after the division has submitted a specific written request for the 136 information or when the division determines the individual has a demonstrable pattern of failing 137 to submit the information as required is grounds for the division to take the following actions in 138 accordance with Section 58-1-401: 139 (i) refuse to issue a license to the individual; 140 (ii) refuse to renew the individual's license; 141 (iii) revoke, suspend, restrict, or place on probation the license; 142 (iv) issue a public or private reprimand to the individual; 143 (v) issue a cease and desist order; and 144 (vi) impose a civil penalty of not more than \$1,000 for each dispensed prescription 145 regarding which the required information is not submitted. 146 (b) Civil penalties assessed under Subsection (13)(a)(vi) shall be deposited in the General 147 Fund. 148 (c) The procedure for determining a civil violation of this subsection shall be in

accordance with Section 58-1-108, regarding adjudicative proceedings within the division.

[(14)] (15) (a) All department and the division costs necessary to establish and operate the database shall be funded by appropriations from the General Fund.

- (b) Funding for this section shall be appropriated without the use of any resources within the Commerce Service Fund.
- [(15)] (16) All costs associated with recording and submitting data as required in this section shall be assumed by the submitting drug outlet.
