5 AN ACT RELATING TO PUBLIC SAFETY; AMENDING CERTAIN DRIVER LICENSING
6 FEES; AND PROVIDING AN EFFECTIVE DATE.

7 This act affects sections of Utah Code Annotated 1953 as follows:

10 *Be it enacted by the Legislature of the state of Utah:*

11 Section 1. Section **53-3-105** is amended to read:

12 **53-3-105. Fees for licenses, renewals, extensions, reinstatements, rescheduling, and**
13 **identification cards.**

14 The following fees apply under this chapter:

15 (1) An original class D license application under Section 53-3-205 is [~~\$15~~] \$20.

16 (2) An original class M license application under Section 53-3-205 is [~~\$17.50~~] \$22.50.

17 (3) An original provisional license application for a class D license under Section 53-3-205
18 is [~~\$20~~] \$25.

19 (4) An original provisional license application for a class M license under Section
20 53-3-205 is [~~\$22.50~~] \$27.50.

21 (5) An original application for a motorcycle endorsement under Section 53-3-205 is \$7.50.

22 (6) An original application for a taxicab endorsement under Section 53-3-205 is \$5.

23 (7) A renewal of a class D license under Section 53-3-214 is [~~\$15~~] \$20 unless Subsection
24 (13) applies.

25 (8) A renewal of a class M license under Section 53-3-214 is [~~\$17.50~~] \$22.50.

26 (9) A renewal of a provisional license application for a class D license under Section
27 53-3-214 is [~~\$15~~] \$20.

- 28 (10) A renewal of a provisional license application for a class M license under Section
29 53-3-214 is [~~\$17.50~~] \$22.50.
- 30 (11) A renewal of a motorcycle endorsement under Section 53-3-214 is \$7.50.
- 31 (12) A renewal of a taxicab endorsement under Section 53-3-214 is \$5.
- 32 (13) A renewal of a class D license for a person 65 and older under Section 53-3-214 is
33 [~~\$5~~] \$8.
- 34 (14) An extension of a class D license under Section 53-3-214 is [~~\$12~~] \$15 unless
35 Subsection (20) applies.
- 36 (15) An extension of a class M license under Section 53-3-214 is [~~\$14.50~~] \$17.50.
- 37 (16) An extension of a provisional license application for a class D license under Section
38 53-3-214 is [~~\$12~~] \$15.
- 39 (17) An extension of a provisional license application for a class M license under Section
40 53-3-214 is [~~\$14.50~~] \$17.50.
- 41 (18) An extension of a motorcycle endorsement under Section 53-3-214 is \$7.50.
- 42 (19) An extension of a taxicab endorsement under Section 53-3-214 is \$5.
- 43 (20) An extension of a class D license for a person 65 and older under Section 53-3-214
44 is [~~\$3~~] \$6.
- 45 (21) An original or renewal application for a commercial class A, B, or C license or an
46 original or renewal of a provisional commercial class A or B license under Part 4 of this chapter
47 is:
- 48 (a) [~~\$30~~] \$35 for the written test; and
- 49 (b) [~~\$50~~] \$55 for the skills test.
- 50 (22) Each original CDL endorsement for passengers, hazardous material, double or triple
51 trailers, or tankers is \$5.
- 52 (23) An original CDL endorsement for a school bus under Part 4 of this chapter is \$5.
- 53 (24) A renewal of a CDL endorsement under Part 4 of this chapter is \$5.
- 54 (25) A retake of a CDL written or a CDL skills test provided for in Section 53-3-205 is
55 \$15.
- 56 (26) A retake of a CDL endorsement test provided for in Section 53-3-205 is \$5.
- 57 (27) A duplicate class A, B, C, D, or M license certificate under Section 53-3-215 is [~~\$10~~]
58 \$13.

59 (28) (a) A license reinstatement application under Section 53-3-205 is \$25.

60 (b) A license reinstatement application under Section 53-3-205 for an alcohol, drug, or
61 combination of alcohol and any drug-related offense is \$25 in addition to the fee under Subsection
62 (28)(a).

63 (29) An administrative fee for license reinstatement after an alcohol, drug, or combination
64 of alcohol and any drug-related offense under Section 41-6-44.10, 53-3-223, or 53-3-231 or an
65 alcohol, drug, or combination of alcohol and any drug-related offense under Part 4 of this chapter
66 is \$150. This administrative fee is in addition to the fees under Subsection (28).

67 (30) An administrative fee for license reinstatement after confiscation under Section
68 53-3-226 is \$25.

69 (31) (a) An administrative fee for providing the driving record of a driver under Section
70 53-3-104 or 53-3-420 is \$4.

71 (b) The division may not charge for a report furnished under Section 53-3-104 to a
72 municipal, county, state, or federal agency.

73 (32) A rescheduling fee under Section 53-3-205 or 53-3-407 is \$25.

74 (33) An identification card application under Section 53-3-808 is [~~\$5~~] \$8.

75 Section 2. **Effective date.**

76 This act takes effect on July 1, 1999.
