20	(1) (a) There is reauthorized the Electric Deregulation and Customer Choice Task Force
21	created by Chapter 176, Laws of Utah 1997, consisting of the following members:
22	(i) five members of the Senate appointed by the president of the Senate, no more than three
23	of whom may be from the same political party; and
24	(ii) seven members of the House of Representatives appointed by the speaker of the House
25	of Representatives, no more than five of whom may be from the same political party.
26	(b) (i) The president of the Senate shall designate a member of the Senate appointed under
27	Subsection (1)(a)(i) as a cochair of the task force.

28	(ii) The speaker of the House of Representatives shall designate a member of the House
29	of Representatives appointed under Subsection (1)(a)(ii) as a cochair of the task force.
30	(c) In conducting its business, the task force shall comply with the rules of legislative
31	interim committees.
32	(d) (i) The task force shall meet at least twice each year, but may meet quarterly, if the
33	chairs determine that the additional meetings are needed.
34	(ii) If the chairs determine that the task force should meet more than quarterly each year,
35	the chairs of the task force may ask for approval of additional meetings from the Legislative
36	Management Committee.
37	(e) Salaries and expenses of the members of the task force shall be paid in accordance with
38	Section 36-2-2 and Legislative Joint Rule 15.03.
39	(f) The Office of Legislative Research and General Counsel shall provide staff support to
40	the task force.
41	(2) The task force shall:
42	(a) study possible electrical restructuring in and its effects on Utah;
43	(b) remain informed about developments in electrical restructuring on the federal level and
44	in other states; and
45	(c) monitor states that have implemented an electrical restructuring plan to learn from the

50	(4) The task force shall report at least annually to the Public Utilities and Technology
