29 (4) If the amount of money in the account at the end of a school year is less than the total

30 of the reimbursable costs, the state superintendent of public instruction shall allocate the money

31 to each school district in the same proportion that its reimbursable costs bear to the total

33 (5) If the amount of money in the account at the end of any school year is more than the

total of the reimbursement costs, the superintendent may allocate the excess funds to school
