20	(c) "Proportionate share" means the percentage of the total sales and use taxes deposited

the day on which the sales and use taxes deposited into the Olympic Special Revenue Fund equal the base amount and ending on the day on which the disbursement is made to the county or municipality;

- (b) on or before [January] March 15, 2002, each county or municipality other than a county or municipality described in Subsection (2)(c) shall receive the county's or municipality's proportionate share of amounts deposited into the Olympic Special Revenue Fund by a public sports entity as reimbursement of sales and use taxes deposited under Subsection 59-12-103(4); and
- (c) by no later than May 5, 2003, there may be distributed to any county or municipality that has entered into an indemnification agreement with the state regarding risks related to the Winter Olympic Games of 2002:
- (i) the proportionate share of amounts deposited into the Olympic Special Revenue Fund by a public sports entity as reimbursement of sales and use taxes deposited under Subsection 59-12-103(4); and
- (ii) interest on the amounts described in Subsection (2)(c)(i) for the period beginning on January 15, 2002, and ending on the day on which the disbursement is made to the county or municipality; and
- (d) any monies in the Olympic Special Revenue Fund after the disbursement under Subsection (2)(c) shall be deposited in the General Fund.
