(A) any conference in which the Office of the Public Advocate participates pursuant to Section 54-7-11.5, if the conference is on a matter in which residential or small commercial consumers have a substantial interest; and (B) each adjudicatory proceeding in which residential or small commercial consumers have a substantial interest; and (ii) may provide resources described in Subsections 54-10a-3(2)(a) and (b) and Section 54-10a-4 to members of the staff of the Office of the Public Advocate to perform their duties under this Subsection (2).

11. Page 36, Lines 1097-1098:Delete lines 1097 through 1098 and insert the following:

"The attorney general shall appoint sufficient full time legal counsel to assist, advise, and represent the Office of the Public Advocate and its staff in the discharge of its duties and in all proceedings before the Public Service Commission, and in all other proceedings."

"(a) set agendas and hold monthly meetings, and may hold other meetings, at the times and places as the chair or a majority of the advisory board may determine; and
