20	(b) "Statewide conservation permit" means a permit:
21	(i) issued by the division;
22	(ii) distributed through a nonprofit organization founded for the purpose of promoting

26	(B) for the species of big game and time period designated by the Wildlife Board.

34	(b) Hunter orange material must be worn on the head, chest, and back.
35	(c) A camouflage pattern in hunter orange does not meet the requirements of Subsection
36	[ <del>(1)</del> ] <u>(2)</u> (a).
37	[(2)] (3) A person is not required to wear hunter orange material during an archery,
38	muzzle-loader, <b>h</b> MOUNTAIN GOAT, <b>h</b> or bighorn sheep hunt, unless a centerfire rifle hunt is in
