

**Representative Craig W. Buttars** proposes to substitute the following bill:

**UTAH FOREST PRACTICES ACT**

2001 GENERAL SESSION

STATE OF UTAH

**Sponsor: Craig W. Buttars**

**This act modifies provisions related to the Division of Forestry, Fire and State Lands and enacts the Utah Forest Practices Act. This act requires the registration of operators and notification by operators of intent to conduct forest practices. This act directs the Division of Forestry, Fire and State Lands to promote the implementation of Forest Water Quality Guidelines, and allows the Division of Forestry, Fire and State Lands to provide technical assistance to landowners regarding forest practices.**

*Be it enacted by the Legislature of the state of Utah:*

Section 1. Section **65A-8a-101** is enacted to read:

**CHAPTER 8a. UTAH FOREST PRACTICES ACT**

**65A-8a-101. Title.**

This chapter is known as the "Utah Forest Practices Act."

Section 2. Section **65A-8a-102** is enacted to read:

**65A-8a-102. Definitions.**



26 As used in this chapter:

27 (1) (a) "Forest practice" means, except as provided in Subsection (1)(b):

28 (i) the harvesting of trees;

29 (ii) new road construction associated with harvesting or accessing trees;

30 (iii) site preparation for regeneration of a timber stand;

31 (iv) reforestation; or

32 (v) the management of logging slash.

33 (b) "Forest practice" does not include:

34 (i) the operation of a nursery or Christmas tree farm;

35 (ii) the harvest of Christmas trees;

36 (iii) the harvest of trees for the noncommercial, personal use by the owner of forested land  
37 from which the trees are harvested; or

38 (iv) a harvesting operation encompassing fewer than ten contiguous acres of forested land.

39 (2) "Forested land" means land, except land owned by the federal government, growing  
40 tree species which are, or could be at maturity, capable of furnishing raw material used in the  
41 manufacture of lumber or other forest products.

42 (3) "Forest Water Quality Guidelines" means the field-applicable practice guidelines  
43 adopted by the division for use during forestry activities to protect water quality and contained  
44 within a nonpoint source management plan.

45 (4) "Landowner" means a person who holds an ownership interest in forested land.

46 (5) "Operator" means a person who:

47 (a) is responsible for conducting forest practices; or

48 (b) through a contractual agreement with the landowner, is obligated to or entitled to  
49 conduct forest practices or to carry out a timber sale.

50 Section 3. Section **65A-8a-103** is enacted to read:

51 **65A-8a-103. Registration of operators.**

52 (1) An operator intending to conduct forest practices in Utah, except a landowner  
53 conducting forest practices on his or her own land, shall register with the division.

54 (2) The operator shall submit the following information to the division:

55 (a) the name of the company;

56 (b) the name of the state where the company is incorporated; and

57 (c) the name, telephone number, and address of a company officer and an on-the-ground  
58 supervisor.

59 (3) In consultation with industry representatives, the division may establish, by rule,  
60 minimum requirements for registration of operators in accordance with Title 63, Chapter 46a, Utah  
61 Administrative Rulemaking Act.

62 (4) The division shall make available to landowners a list of registered operators.

63 Section 4. Section **65A-8a-104** is enacted to read:

64 **65A-8a-104. Notification of intent to conduct forest practices.**

65 (1) No later than 30 days prior to an operator commencing forest practices, the operator  
66 shall notify the division of the operator's intent to conduct forest practices.

67 (2) The notification shall include:

68 (a) the name and address of the operator;

69 (b) the name and address of the landowner;

70 (c) a legal description of the area in which the forest practices are to be conducted; and

71 (d) a description of the proposed forest practices to be conducted, including the number  
72 of acres with timber to be harvested.

73 (3) Upon the receipt of notification, the division shall, within ten days, mail to the  
74 landowner and the operator:

75 (a) an acknowledgment of notification;

76 (b) information on Forest Water Quality Guidelines; and

77 (c) any other information the division believes would assist the landowner and operator  
78 in conducting forest practices.

79 Section 5. Section **65A-8a-105** is enacted to read:

80 **65A-8a-105. Division to promote implementation of Forest Water Quality Guidelines.**

81 (1) The division shall promote implementation of Forest Water Quality Guidelines before,  
82 during, and after the conduct of forest practices on forested land in order to:

83 (a) preserve water quality and soil stability;

84 (b) prevent the hazard of fire and insect infestation;

85 (c) minimize waste of timber resources; and

86 (d) protect the regenerative and productive capacity of forested land.

87 (2) The division, in cooperation with Utah State University Extension Services:

88           (a) shall implement a program to develop demonstration areas, books, brochures,  
89 informational material, seminars and workshops, and other aids to display correct application of  
90 the Forest Water Quality Guidelines; and

91           (b) may aid private landowners by providing technical assistance to landowners and  
92 operators in implementing Forest Water Quality Guidelines.

93           Section 6. Section **65A-8a-106** is enacted to read:

94           **65A-8a-106. Division to provide technical assistance.**

95           (1) The division may provide:

96           (a) advice and technical assistance to landowners and operators by:

97           (i) developing forest stewardship plans;

98           (ii) developing harvest or forest management plans; and

99           (iii) developing programs and activities promoting stewardship of forest and other lands;

100           (b) information about tax incentives or other financial incentives designed to enhance the  
101 productive potential of forested land; or

102           (c) federal cost-share incentives to eligible nonindustrial, private forest landowners if  
103 available.

104           (2) The division, in cooperation with Utah State University Extension Services shall:

105           (a) develop and implement a public education and awareness program to inform citizens  
106 about the benefits of long-term stewardship of forest and other lands; and

107           (b) provide technical assistance to landowners in developing management plans that may  
108 be required for financial incentive programs.
