

**SUNSET REAUTHORIZATIONS**

2001 GENERAL SESSION

STATE OF UTAH

**Sponsor: Millie M. Peterson**

**This act reauthorizes certain state entities and programs that would otherwise sunset before the 2002 Annual General Session of the Utah Legislature.**
