15	(1) A student may be suspended or expelled from a public school for any of the following

17	(a) frequent or flagrant willful disobedience, defiance of proper authority, or disruptive
18	behavior, including the use of foul, profane, vulgar, or abusive language;
19	(b) willful destruction or defacing of school property;
20	(c) behavior or threatened behavior which poses an immediate and significant threat to the
21	welfare, safety, or morals of other students or school personnel or to the operation of the school;
22	(d) possession, control, or use of an alcoholic beverage as defined in Section 32A-1-105;
23	or
24	(e) behavior proscribed under Subsection (2) which threatens harm or does harm to the
25	school or school property, to a person associated with the school, or property associated with any
26	such person, regardless of where it occurs.
27	(2) (a) A student shall be suspended or expelled from a public school for any of the

following reasons:

(i) any serious violation affecting another student or a staff member, or any serious violation occurring in a school building, in or on school property, or in conjunction with any school activity, including the possession, control, or actual or threatened use of a real, look alike, or pretend weapon, explosive, or noxious or flammable material under Section 53A-3-502, or the sale, control, or distribution of a drug or controlled substance as defined in Section 58-37-2, an imitation controlled substance defined in Section 58-37b-2, or drug paraphernalia as defined in Section 58-37a-3; or

- (ii) the commission of an act involving the use of force or the threatened use of force which if committed by an adult would be a felony or class A misdemeanor.
- (b) A [secondary school] student who commits a violation of Subsection (2)(a) involving a real, look alike, or pretend firearm, explosive, or flammable material shall be expelled from school for a period of not less than one year [-] subject to the following:
- [(c) If an elementary school student commits a violation of Subsection (2)(a) involving a real or look alike firearm, explosive, or flammable material or if a secondary school student commits a violation of Subsection (2)(a) involving a look alike or pretend firearm, explosive, or flammable material, the student shall be expelled from school for a period of not less than one year subject to the following:]
- (i) within 45 days after the expulsion the student shall appear before the student's local school board superintendent or [his] the superintendent's designee, accompanied by a parent or legal guardian; and
 - (ii) the superintendent shall determine:
- (A) what conditions must be met by the student and the student's parent for the student to return to school;
- (B) if the student should be placed on probation in a regular or alternative school setting consistent with Section 53A-11-907, and what conditions must be met by the student in order to ensure the safety of students and faculty at the school the student is placed in; and
- (C) if it would be in the best interest of both the school district and the student to modify the expulsion term to less than a year, conditioned on approval by the local school board and giving highest priority to providing a safe school environment for all students.
