18	The amount of damages awarded for [such] noneconomic loss may not exceed [\$250,000. This

20	(a) for a cause of action arising before July 1, 2001, \$250,000;
21	(b) for a cause of action arising on or after July 1, 2001 and before July 1, 2002, \$500,000;
22	<u>and</u>
23	(c) for a cause of action arising on or after July 1, 2002, the \$500,000 limitation described
24	in Subsection (1)(b) shall be adjusted for inflation as provided in Subsection (2).
25	(2) (a) Beginning July 1, 2002 and each July 1 thereafter, the limit for damages under
26	Subsection (1)(c) shall be adjusted for inflation by the state treasurer.

33	(3) As used in this section, "inflation" means the seasonally adjusted consumer price index

36	(4) The limit under Subsection (1) does not [affect] apply to awards of punitive damages.

38	This act has prospective effect only and any changes to the law caused by this act do not
39	apply to any claims based upon injuries or losses that occurred before July 1, 2001.

41	This act takes effect on July 1, 2001.
