

Senator Howard A. Stephenson proposes to substitute the following bill:

CONSTRUCTION BID LIMIT AMENDMENTS

2001 GENERAL SESSION

STATE OF UTAH

Sponsor: Howard A. Stephenson

This act modifies State Affairs in General by requiring the Privatization Policy Board to study and make a report on constructions bid limits for municipal and county public works project. The act provides a repeal date of November 1, 2001.

This act affects sections of Utah Code Annotated 1953 as follows:

AMENDS:

63-55-263, as last amended by Chapters 1, 78 and 281, Laws of Utah 2000

ENACTS:

63-55a-4, Utah Code Annotated 1953

Be it enacted by the Legislature of the state of Utah:

Section 1. Section **63-55-263** is amended to read:

63-55-263. Repeal dates, Titles 63, 63A, and 63C.

(1) (a) Title 63, Chapter 25a, Part 1, Commission on Criminal and Juvenile Justice, is repealed July 1, 2002.

(b) Title 63, Chapter 25a, Part 3, Sentencing Commission, is repealed January 1, 2002.

(2) The Crime Victims' Reparations Board, created in Section 63-25a-404, is repealed July 1, 2007.

(3) The Resource Development Coordinating Committee, created in Section 63-28a-2, is repealed July 1, 2004.

(4) Title 63, Chapter 38c, State Appropriations and Tax Limitation Act, is repealed July 1, 2005.

(5) Section 63-55a-4, authorizing a study of construction bid limits for public works

36 (1) The board shall study and make a report and recommendations on the following issues
37 related to municipal and county public works projects:

38 (a) construction bid limits required or recommended for public works projects that should
39 be let out for bid by public or private contract; and

40 (b) effective enforcement, adjudication, and sanctions for violations of construction bid
41 limits.

42 (2) (a) A final report, including recommendations, shall be presented to an interim
43 committee of the Legislature as assigned by the Legislative Management Committee.
