6	and driver license applications and renewals for the purpose of providing public
7	transportation for seniors or people with disabilities. The act creates the "Out and About"
8	Homebound Transportation Assistance Fund. The act modifies the duties of the Division of
9	Aging and Adult Services to include administration of the fund, and provides rulemaking
10	authority to the division. The act provides an effective date.

23	designate a voluntary contribution of \$1 for public transportation assistance for seniors or people
24	with disabilities.

95	of information, statistics, and reports relating to issues facing aging and adult citizens.
96	(8) The division has authority to prepare and submit reports regarding the operation and
97	administration of the division to the department, the Legislature, and the governor, as requested.
