1st Sub. H.B. 64 Consumer Protection Amendments (A. Bradshaw)

Rep. Bradshaw introduced the bill.

MOTION: Rep. Bradshaw moved to amend the bill as follows:

1. Page 4, Line 91: After "be [determined as follows]" delete "set by the director of

the division at a reasonable level" and insert a colon

2. Page 4, Lines 92, 93: Delete lines 92, 93

3. Page 4, Line 94: After "(i)" delete "\$50,000" and insert "\$25,000"

4. Page 4, Line 97: After "application" insert "and the telephone soliciting business

has fewer than ten employees;"

5. Page 4, Line 98: Bracket and delete "<u>:or</u>" and after line 98 insert:

"(ii) \$50,000 if neither the telephone soliciting business nor any affiliated person has violated this chapter within three years preceding the date of the application and the telephone soliciting

business has ten or more employees; or"

6. Page 4, Line 99: At the beginning of line 99 bracket "(ii)" and insert "(iii)"

(B) any information regarding an applicant's or insured's

insurance claim history."

1. Page 2, Line 42: Delete line 42
