H.B. 342 Recovery of Damages for Loss of Use of a Motor Vehicle (G. Curtis)

MOTION: Representative Curtis moved to delete H.B. 342, and replace it with 1st Substitute H.B. 342 "Recovery of Damages for Loss of a Motor Vehicle". The motion passed unanimously with Representative Bigelow absent for the vote.
