H.B. 285 Historic Building Rehabilitation Tax Credits (*C. Bennion*)

Rep. Bennion introduced and explained the bill to the committee.

H.B. 296 2002 Special Highway General Obligation Bonds (*W. Harper*)

1. Page 1, line 11: After "**bonds.**" insert "**This act exempts bonds issued from statutory debt limitation requirements.**"
2. Page 3, line 86: After "6200 South:" delete "and" and after line 86 insert:
 (G) 11400 South: I-15 to Redwood Road; and
3. Page 3, line 87: Delete "(G)" insert "(H)"
4. Page 4, lines 100-101: Delete lines 100-101
