THIS ACT PROVIDES REVISOR'S INSTRUCTIONS TO CORRECT ERRORS IN INTRODUCTORY CAPTIONS FOUND IN H.B. 25, ADULT PROTECTIVE SERVICES AMENDMENTS, PASSED DURING THE 2002 ANNUAL GENERAL SESSION. THIS ACT PROVIDES AN IMMEDIATE EFFECTIVE DATE AND HAS RETROSPECTIVE OPERATION TO MAY 6, 2002, WHICH IS THE EFFECTIVE DATE OF THE ORIGINAL BILL, read the first time by short title.

THIS ACT MODIFIES THE DRIVING WHILE INTOXICATED AND RECKLESS DRIVING ARTICLE OF THE MOTOR VEHICLES CODE. THE ACT PROVIDES A TIME LINE FOR ALL COURTS TO COLLECT AND MAINTAIN DATA ON OFFENSES UNDER THE ARTICLE. THE ACT REQUIRES ANNUAL REPORTS BY THE ADMINISTRATIVE OFFICE OF THE COURTS TO THE JUDICIARY AND TRANSPORTATION INTERIM COMMITTEES. THIS ACT PROVIDES AN IMMEDIATE EFFECTIVE DATE, read the first time by short title.
