State Impact

Implementation of this bill appropriates \$3,528,564 for Alternative Language Services (ALS) currently provided in the Interventions for Student Success Block Grant in the Minimum School Program.

This bill requires the State Board of Education to employ a third-party evaluator. Bill provisions allow for this position to be funded out of the funds appropriated for ALS.

Individual and Business Impact

No fiscal impact.
