6   **This resolution modifies Senate Rules governing the Order of Business by adding the**  
7   **Pledge of Allegiance to the Daily Order of Business. This resolution takes effect**  
8   **immediately.**

11                   **SR-23.03**

12   *Be it resolved by the Senate of the state of Utah:*

13           Section 1. **SR-23.03** is amended to read:

14           **SR-23.03. Daily Order of Business.**

15           The daily order of business is:

- 16           (1) call to order by President;
- 17           (2) roll call;
- 18           (3) report of excused absences and if quorum is present;
- 19           (4) prayer and Pledge of Allegiance;
- 20           (5) report of journal committee;
- 21           (6) communications from the Governor;
- 22           (7) communications from the House:
- 23           (a) bills for signature of the President;
- 24           (b) bills for consideration; and
- 25           (c) bills for reconsideration of House amendments;
- 26           (8) reference of bills from the President:
- 27           (a) bills assigned to standing committees; and



- 28 (b) bills placed on second reading calendar;
- 29 (9) reports of Secretary of the Senate from standing committees:
- 30 (a) bills placed on second reading calendar;
- 31 (b) bills placed on consent calendar; and
- 32 (c) bills sent back to the Secretary of the Senate;
- 33 (10) reports of special committees, including conference committees;
- 34 (11) introduction of bills and presentation of resolutions to be given to the Secretary of
- 35 the Senate at least one hour before the beginning of the session for inclusion in that day's
- 36 agenda:
- 37 (a) bills assigned to Secretary of the Senate for referral by the President; and
- 38 (b) bills placed on second reading calendar;
- 39 (12) unfinished business;
- 40 (13) consideration of bills on consent calendar;
- 41 (14) special orders of business;
- 42 (15) consideration of bills on third reading calendar;
- 43 (16) consideration of bills on second reading calendar; and
- 44 (17) miscellaneous business.
- 45 **Section 2. Effective date.**
- 46 This resolution takes effect upon approval by a constitutional majority vote of all
- 47 members of the Senate.
