Rep. Bryson called the meeting to order at 2:15 p.m.

MOTION: Rep. Hansen moved to approve the minutes of the January 21, 2003 meeting. The motion passed unanimously, with Rep. Morley absent for the vote.

H.B. 78 Lien Recovery Fund - Rate of Interest (G. Snow)

MOTION: Rep. Ferry moved to delete in title and body **H.B. 78** and replace it with **1st Substitute H.B. 78**. The motion passed unanimously, with Rep. Morley absent for the vote.

Rep. Snow introduced the bill.

MOTION: Rep. D. Clark moved to pass the bill out favorably.

SUBSTITUTE

MOTION: Rep. Morley moved to amend the bill as follows:

1. Page 2, Lines 30-35: Delete lines 30 through 35
2. Page 2, Line 36: Delete “(e)” and insert “(c)”
3. Page 2, Line 41: Delete “(f)” and insert “(d)”
4. Page 2, Line 44: Delete “of” and insert “not to exceed”
5. Page 2, Line 45: Delete “or \$300, whichever is greater”

The substitute motion passed, with Rep. Biskupski, Rep. D. Clark, and Rep. Hansen voting in opposition.

MOTION: Rep. Dunnigan moved to amend the bill as follows:

Page 2, Line 44: Delete “in the amount”

The motion passed unanimously.

MOTION: Rep. Buttars moved to pass the bill out favorably as amended. The motion passed unanimously.

H.B. 166 Payday Lending (T. McCartney)

Rep. McCartney introduced the bill.

MOTION: Rep. Hansen moved to amend the bill as follows:

1. Page 2, line 53: Delete “once every three years” and insert “annually”

The motion passed, with Rep. Adams, Rep. Bryson, Rep. Kiser and Rep. Morley voting in opposition.

MOTION: Rep. Ferry moved to amend the bill as follows:

1. Page 2, lines 39 through 41: Delete Lines 39 through 41

The motion failed, with Rep. Bryson, Rep. Buttars, Rep. D. Clark, Rep. Ferry and Rep. Morley voting in favor.

SUBSTITUTE

MOTION: Rep. D. Clark moved to adjourn the meeting. The motion failed, with Rep. Biskupski, Rep. Duckworth, Rep. Dunnigan, Rep. Hansen, Rep. Kiser and Rep. Parker voting in opposition.

The original motion to pass the bill out favorably as amended passed, with Rep. Adams, Rep. Bryson, Rep. D. Clark, Rep. Dunnigan and Rep. Ferry voting in opposition.

H.B. 48 Utah Construction Trade Licensing Act Amendments (*S. Urquhart*)

This bill was not heard at the meeting.
