## 1. <u>S.B. 182 INDIVIDUAL INCOME TAX - CONTRIBUTION TO BOYS AND GIRLS CLUBS OF AMERICA</u> (Sen. D. C. Buttars)

Sen. Buttars presented the bill to the committee.

3. Page 1, Line 20 Delete "\$5,600,000" and insert "\$6,100,000"

The motion passed with Sen. Waddoups voting against and Sen. Dmitrich absent at the time of the vote.

**MOTION:** Sen. Stephenson moved to pass S.B. 224, as amended, out of committee with a favorable recommendation.

The motion failed with Sen. Allen, Sen. Dmitrich and Sen. Waddoups voting against.
