1. 2ND Sub. H.B. 114 MANAGEMENT, ENHANCEMENT AND FUNDING OF 911 SYSTEM (Rep. B. Dee)

MOTION: Sen.Gladwell moved to refer 2nd Sub. H. B. 114 to the rules committee for interim study.

2. S.B. 253 PRIVILEGE TAX - PUBLIC LAND (Sen. T. Hatch)
