1. Page 1, Lines 5-7b

After "suspected violation." insert "**Beginning July 1, 2013, this act amends the safety belt requirements by making the requirement to wear a safety belt only apply to persons under 19 years of age.**"

"Section 2. Section **41-6-182** is enacted to read:

41-6-182.1. Driver and passengers -- Seat belt or child restraint device required.

(1) Beginning July 1, 2013, the driver of a motor vehicle operated on a highway shall:

(a) if the driver is under 19 years of age wear a properly adjusted and fastened safety belt;

(b) provide for the protection of each person younger than five years of age by using a child restraint device to restrain each person in the manner prescribed by the manufacturer of the device; and

(c) provide for the protection of each person five years of age up to 16 years of age by using an appropriate child restraint device to restrain each person in the manner prescribed by the manufacturer of the device or by securing, or causing to be secured, a properly

adjusted and fastened safety belt on each person.

(2) Beginning July 1, 2013 a passenger who is under 19 years of age or older of a motor vehicle operated on a highway shall wear a properly adjusted and fastened safety belt.

(3) In accordance with Title 63, Chapter 46a, Utah Administrative Rulemaking Act, the commissioner of the Department of Public Safety shall set standards for approved safety belts and child restraint devices.

(4) If more than one person is not using a child restraint device or wearing a safety belt in violation of Subsection (1), it is only one offense and the driver may receive only one citation.

Section 3. Section **63-55-241** is amended to read:

63-55-241. Repeal dates, Title 41.

The following provisions of Title 41 are repealed on the following dates:

(1) Section 41-6-182, Driver and passengers -- Seat belt or child restraint device required, is repealed July 1, 2013.
