requires a school district or charter school to:

38	Section 1. Section 53A-17a-150 is enacted to read:					
39	53A-17a-150. Performance Plus K-3 Reading Improvement Program.					
40	(1) The Performance Plus K-3 Reading Improvement Program is created to achieve the					
41	state's goal of having third graders reading at or above grade level.					
42	(2) The Legislature shall annually appropriate money to the State Board of Education					
43	to be distributed to school districts and charter schools to participate in the Performance Plus					
44	K-3 Reading Improvement Program.					
45	(3) (a) To qualify for program monies, a school district or charter school shall submit a					
46	plan for reading proficiency improvement that incorporates the following components:					
47	(i) assessment;					
48	(ii) intervention strategies;					
49	(iii) professional development;					
50	(iv) reading performance standards; and					
51	(v) specific measurable goals.					
52	(b) The State Board of Education shall provide model plans which a school district or

63	(b) 60% shall be distributed based upon the number of students in a school district or
64	elementary charter school who qualify for free or reduced price school meals as a proportion of
65	the total number of students who qualify for free or reduced price school meals in qualifying
66	school districts and elementary charter schools.
67	(5) Each school district and charter school shall use its allocation of Performance Plus

80	There is appropriated from the Uniform School Fund to the State Board of Education

83	(2) as an ongoing appropriation subject to future budget constraints, \$25,000,000 for
84	<u>fiscal year 2004-05.</u>
85	Section 3. Effective date.
