H.B. 55 School and Institutional Trust Land Amendments (Rep. M. Noel)

MOTION: Rep. Noel moved to amend HB 55 as follows:

- 19 Other Special Clauses:
- 20 [[None]] This bill provides an immediate effective date.
 - 2. *Page 3, Lines 84 through 87:*
- 84 (7) Upon payment in full of principal and interest and the surrender of the original
- 85 certificate of sale for any tract of land sold, or payment in full of any amounts required to be
- paid for the partial release of property, the [[+]] **governor** [[+]] [[-director-]] , or the governor's designee, shall issue a patent to the

- purchaser, heir, assignee, successor in interest, or other grantee as determined by the director.
 - 3. Page 4, Lines 105 through 106:
- (b) [Upon request of the director, the governor] The director , upon authorization from the governor, shall execute and deliver
- the necessary patents to other proprietors and receive proper deeds for the lands exchanged.
 - 4. Page 4, Line 113:
- 113 (b) The state shall honor all vested rights upon acceptance of exchanged lands.

 Section 4. Effective date.
 - If approved by two-thirds of all the members elected to each house, this bill takes effect upon approval by the governor, or the day following the constitutional time limit of Utah Constitution Article VII, Section 8, without the governor's signature, or in the case of a veto, the date of veto override.
