8 **LONG TITLE**

9 **General Description:**

10 This bill amends H.B. 3, 2004 Supplemental Appropriations Act II, to redirect federal
11 funds appropriated for purchase of the Oxbow Jail to other Department of Corrections
12 inmate housing projects and to direct certain General Fund one-time monies to
13 construction of an inmate training center.

14 **Highlighted Provisions:**

15 This bill:

- 16 ▶ requires that up to \$1.5 million in federal VOI/TIS Funds be allocated to the
17 Department of Corrections for capital improvements; and
18 ▶ directs that 1.54 million in one-time General Fund monies be used to construct an
19 inmate training center for the Wasatch and Oquirrh facilities of the Department of
20 Corrections.

21 **Monies Appropriated in this Bill:**

22 This bill does not appropriate any monies but does modify legislative intent regarding
23 the use of certain federal grant monies.

24 **Other Special Clauses:**

25 This bill provides an immediate effective date.

28 **Item 20, Chapter 370, Laws of Utah 2004**



30 *Be it enacted by the Legislature of the state of Utah:*

31 **Section 1. General provisions.**

32 Under the terms and conditions of Section 63-38-3, the following sums of money
 33 are appropriated from resources not otherwise appropriated, or reduced from amounts
 34 previously appropriated, out of the funds or fund accounts indicated for the use and support of
 35 the government of the State of Utah for the fiscal year beginning July 1, 2004 and ending June
 36 30, 2005. This is an addition to or a subtraction from amounts appropriated by S. B. 1,
 37 Appropriations Act, 2004 General Session.

38 Section 2. **Item 20, Chapter 370, Laws of Utah 2004** is amended to read:

44 The Legislature intends that the Commission on Criminal
 45 and Juvenile Justice apply [~~\$2.2~~] up to \$1.5 million in Federal VOI/TIS
 46 Funds [~~to the purchase of the Oxbow Jail~~] for capital improvements in
 47 the Department of Corrections.

48 It is the intent of the Legislature that the \$1.54 million from General Fund One-time
 49 monies be used to construct an inmate training center for the Department of Corrections'
 50 Wasatch and Oquirrh facilities.

51 **Section 3. Effective date.**

52 If approved by two-thirds of all the members elected to each house, this bill takes effect
 53 upon approval by the governor, or the day following the constitutional time limit of Utah
 54 Constitution Article VII, Section 8, without the governor's signature, or in the case of a veto,
 55 the date of veto override.
