

Representative Sheryl L. Allen proposes the following substitute bill:

SPECIAL HUNTING PERMITS FOR

SNOW CANYON STATE PARK

2005 GENERAL SESSION

LONG TITLE

General Description:

This bill provides for the issuance of special hunting permits in Snow Canyon State Park.

Highlighted Provisions:

This bill:

- ▶ allows the Wildlife Board to set rules regarding the issuance of special hunting permits in Snow Canyon State Park; and

- ▶ provides that if the Wildlife Board issues coyote and fox permits for hunting in Snow Canyon State Park, the Board of Parks and Recreation must allow access for hunting and camping activities related to the use of those special hunting permits in Snow Canyon State Park.

Other Special Clauses:

This bill takes effect on January 1, 2006.

32 Section 1. Section **23-19-22.1** is enacted to read:

33 **23-19-22.1. Special big game hunting permits in Snow Canyon State Park.**

34 (1) The Wildlife Board may make rules relating to the issuance of special hunting
35 permits for hunting in Snow Canyon State Park.

36 (2) If provided for by rule, the permits in Subsection (1) shall be issued as follows:

37 (a) two permits issued annually for taking coyote in Snow Canyon State Park; and

38 (b) two permits issued annually for taking fox in Snow Canyon State Park.

39 Section 2. Section **63-11-19.3** is enacted to read:

40 **63-11-19.3. Hunting in Snow Canyon State Park.**

41 (1) If the Wildlife Board provides by rule that special coyote and fox hunting permits
42 may be issued under the provision of Section 23-19-22.1, the Board of Parks and Recreation
43 shall authorize foot access and access for camping for hunting parties in Snow Canyon State
44 Park for the following:

45 (a) two parties of coyote hunters; and

46 (b) two parties of fox hunters.

47 (2) A party shall consist of no more than five people and five horses.
