The Transportation and Public Utilities and Technology Committee reports a favorable recommendation on **H.B. 65, DRIVER LICENSE AND COMMERCIAL DRIVER LICENSE AMENDMENTS**, by Representative D. Bowman, with the following amendments:

(12) (a) Subject to Subsection (12)(b), a driver of a motor vehicle who holds or is required to hold a CDL is disqualified for not less than:

(i) 60 days from driving a commercial motor vehicle if the driver is convicted of two serious traffic violations; and

(ii) 120 days if the driver is convicted of three or more serious traffic violations.

(b) The disqualifications under Subsection (12)(a) are effective only if the serious traffic violations:

(i) occur within three years of each other;

(ii) arise from separate incidents; and

(iii) result in a the denial, suspension, cancellation, or revocation of the non-CDL driving privilege from at least one of the violations.
