1. S.B. 0083 Medical Decisions of a Parent or Guardian (D. Thomas)

Sen. Thomas explained the bill.

2. **S.B. 77 Amendments to Indoor Clean Air Act** (M. Waddoups)

Sen. Waddoups explained the bill.

1. *Page 2, Lines 32 through 33:*

32 (1) ~~{Smoking}~~ **Except as provided in Subsection (2), smoking** is
prohibited **:**
(a) in all enclosed indoor places of public access and publicly
33 owned buildings and offices ~~{, except under Subsection (2)}~~ **;** **and**
(b) in private clubs as defined in Section 26-38-2 .

MOTION: Sen Knudson moved that the committee adopt the amendment to S.B. 77.

The motion passed with Sen. Bell absent at the time of the vote.

3. **S.B. 19 Disease Testing of Individuals Exposed to Blood Borne Pathogens**
(P. Julander)
