**1. H.B. 95 SEX OFFENDER REGISTRATION AMENDMENTS (Rep. M. S. Lawrence)**

Rep. Lawrence presented the bill to the committee.

Blake Chard, Juvenile Justice Services, spoke to the bill

**MOTION:** Sen. Arent moved to pass H. B. 95 out of committee with a favorable recommendation.

**2. S.B. 216 AMENDMENTS TO UTAH EMERGENCY MEDICAL SERVICES ACT  
(Sen. C. Bramble)**

Sen. Bramble presented the bill to the committee assisted by Cathy Dupont, Legislative General Council.

Michael Jensen, Chairman, Salt Lake City; Council; Scott Freitag, Salt Lake City Fire Department, and Don Berry, Chief, Unified Fire Association, spoke in favor of the bill.

Mike Moffitt, Gold Cross Ambulance, spoke in opposition to the bill.

**MOTION:** Sen. Arent moved to pass S.B. 216 out of committee with a favorable recommendation.

**3. H.B. 98 OFFENSES COMMITTEE AGAINST CORRECTIONAL AND PEACE OFFICERS (Rep. C. Oda)**

Rep. Oda presented the bill to the committee.

Dan Halacy, Corrections Officer; Wayne Shepherd, Utah Chief of Police, and Wallace McCormick, Citizen, spoke to the bill.

**MOTION:** Rep. Arent moved to pass H.B. 98 out of committee with a favorable recommendation.

**4. H.B. 223 AMENDMENTS TO DRIVER LICENSE AND IDENTIFICATION CARDS (Rep. C. Oda)**

**MOTION:** Sen. Arent moved to amend H.B. 223 as follows:

1. *Page 2, Line 39*

*House Committee Amendments*

*2-11-2005:*

39 This bill takes effect on July 1, 2005. =

**This bill provides a coordination clause.**

2. *Page 5, Line 143:*

143 (c) {~~A~~} **Except as provided under Subsection (8)(f), a** duplicate license  
expires on the same date as the last license certificate issued.

3. *Page 12, Lines 338 through 339:*

338 Section 6. Effective date.

339 This bill takes effect on July 1, 2005. =

= **Section 7. Co-ordinating H.B. 223 with H.B. 227.**

**If this H.B. 223 and S.B. 227, Public Safety Driving Privilege and Identification Card Amendments, both pass, it is the intent of the Legislature that the Office of Legislative Research and General Counsel shall prepare the Utah Code database for publication as follows:**

**(1) the amendments to Sections 53-3-804 and 53-3-807 in S.B. 227 supersede the amendments to Sections 53-3-804 and 53-3-807 in this bill; and**

**(2) in Section 53-3-205:**

**(a) renumber Subsection (8)(f) in S.B. 227 to (8)(g) and change the references from "Subsection (8)(f)" to "Subsections (8)(f) and (g)"; and**

**(b) after Subsection (8)(g)(ii) insert the following:**

**“(iii) The expiration dates provided under Subsections (8)(g)(i) and (ii) do not apply to an original license or driving privilege card or to the renewal of an original license or driving privilege card with an expiration date provided under Subsection (8)(f).”**

The motion passed unanimously.

Rep. Oda presented the bill to the committee.

**MOTION:** Sen. Bell moved to pass H.B. 223, as amended, out of committee with a

favorable recommendation.

**5. H.B. 276 DIVISION OF CRIMINAL INVESTIGATION AND TECHNICAL SERVICES ACT (Rep. C. Oda)**

Rep. Oda presented the bill to the committee.
