Section 1. Section **59-1-214** is enacted to read:

29	(i) each tax credit described in Title 59, Chapter 10, the "Individual Income Tax Act;"	
30	(ii) each subtraction from federal taxable income described in Subsection 59-10-114

32	(iii) each exemption from the sales and use tax described in Section 59-12-104;	
33	(iv) each tax credit described in Title 59, Chapter 7;	
34	(v) the contingent tax credit described in Title 63, Chapter 38f, Part 12, the "Utah	
35	Venture Capital Enhancement Act;"	
36	(vi) each tax credit described in Sections 63-38f-413 and 63-38f-502;	
37	(vii) the exemption described in Section 59-2-103;
