Mr. Speaker:

The Business and Labor Committee reports a favorable recommendation on **H.B. 74**, ATHLETIC TRAINER LICENSING ACT, by Representative P. Ray, with the following amendments:

- 1. Page 6, Lines 162 through 166:
 - 162 (3) "Athletic injury" means:
 - 163 (a) an injury sustained by an athlete that affects the individual's participation or
 - 164 performance in sports, games, recreation, or exercise; or
 - 165 (b) a condition that is within the scope of practice of an athletic trainer identified by a
 - 166 <u>directing physician</u> <u>or physical therapist</u> as benefitting from athletic training services.

2. Page 6, Lines 171 through 177:

- 171 (6) "Directing physician" means a physician and surgeon licensed under Section
- 172 <u>58-67-301, an osteopathic physician and surgeon licensed under Section 58-68-301, a</u>
- 173 chiropractic physician licensed under Chapter 73, Chiropractic Physician Practice Act, a
- 174 naturopathic physician licensed under Chapter 71, Naturopathic Physician Practice Act, or
- 175 <u>dentist licensed under Section 58-69-301 who</u> <u>, within the licensee's scope of practice</u> and individual competency, is responsible for the athletic training services
- 176 provided by the athletic trainer and oversees the practice of athletic training by the athletic
- 177 <u>trainer, as established by board rule.</u>
- 3. Page 7, Lines 189 through 191:
 - 189 (1) A directing physician shall provide direction to an athletic trainer by a verbal order
 - 190 when in the presence of the athletic trainer and by written order or by athletic training service
 - 191 <u>plans or protocols when</u> {<u>the</u>} <u>a</u> <u>directing physician is not present.</u>

- 4. Page 8, Lines 230 through 233:
 - 230 {<u>National Athletic Trainers' Association</u>} Board of Certification <u>Inc.</u> or equivalent examination
 - 231 approved or recognized by the board;
 - 232 (3) is in good standing with and provides documentation of current certification by the
 - 233 {<u>National Athletic Trainers' Association</u>} Board of Certification <u>Inc.</u> or a <u>nationally recognized</u>
