# H.B. 329 Age Amendments for Hunting Big Game (Rep. C. Oda)

Rep. Oda explained the bill to the committee, with the assistance of Jim Karpowitz, Director, Wildlife Resources.

MOTION: Rep. Painter moved to amend the bill as follows:

- 1. Page 2, Lines 33 through 38:
  - 33 (3) (a) Except as provided by Subsection (3)(b), a person who is younger than 14 years
  - 34 <u>old may not</u> <u>apply for or</u> <u>obtain the following types of</u> { <u>permit to hunt</u>} <u>big</u> game <u>permits issued by the division through a public drawing</u>:
  - 35 (i) premium limited entry;
  - 36 (ii) limited entry;
  - 37 (iii) once-in-a-lifetime; and
  - 38 (iv) cooperative wildlife management unit.

# H.B. 145 Rangeland Improvement Act (Rep. B. Johnson)

    - (A) public land;
    - (B) private land;
    - (C) state land; and
    - (D) school and institutional trust land as defined in Section 53C-1-103.
  - 62  $\left[\frac{(4)}{(4)}\right]$  (e) "Public lands" mean  $\left\{\frac{1}{2}\right\}$
  - 63 (1) vacant, unappropriated, reserved, and unreserved federal lands {; and
  - 64 <u>(ii) all lands held by the state, including school and institutional trust lands as</u> <u>defined</u>
  - 65 in Section 53C-1-103
- 2. Page 4, Line 102:
  - 102 (A) management plans for { federal and } public lands, state lands , and school and institutional trust lands as defined in Section 53C-1-103, within the regional board's region;

- 3. Page 4, Line 104:
  - 104 (B) any issue that impacts grazing on private { or } lands, public lands \_ state lands, or school and institutional trust lands as defined in Section 53C-1-103, in its region; and

  - (b) the Utah Woolgrower's Association; {-and}
    (c) the Utah Farm Bureau Federation; and
  - 122 {(c)} (d) a soil conservation district, if the soil conservation district's boundaries include
