**Approval of Minutes**

The motion passed unanimously with Sen. Bramble absent for the vote.

**1. S.B. 226 Registration and Title Provisions** (*D. Eastman*)

The following amendments were distributed:

1. *Page 2, Line 38:*

38            {~~None~~}    **This bill takes effect on July 1, 2006.**

2. *Page 6, Line 165:*

165 dealer is not liable for the registration fee or penalty.

**Section 7. Effective date.**

**This bill takes effect on July 1, 2006.**
