Senator **Scott D. McCoy** proposes the following amendments:

- 1. Page 2, Lines 42 through 44
  House Floor Amendments
  1-27-2006:
  - 42 engaging in incest with the  $\hat{H} \rightarrow [woman] \underline{minor} \leftarrow \hat{H}$ ;  $\{-or\}$
  - the parent or guardian has not assumed responsibility for the minor's care and
  - 44 upbringing; or
    - <u>•</u> <u>the minor obtains the right, by court order, to consent to an abortion without consent from a parent or guardian and the court makes a finding that notification of a parent or guardian of the minor poses a risk of abuse to the minor;</u>
- 2. Page 4, Line 115 through Page 5, Line 134:
  - (3) Subject to Subsection (4), at least 24 hours before a physician performs an abortion
  - on a minor, the physician shall notify a parent or guardian of the minor that the minor intends
  - 117 <u>to have an abortion.</u>
  - 118 (4) A physician is not required to comply with Subsection (3) if:
  - 119 (a) subject to Subsection (5)(a):
  - 120 (i) a medical condition exists that, on the basis of the physician's good faith clinical
  - judgment, so complicates the medical condition of a pregnant minor as to necessitate the
  - abortion of her pregnancy to avert:
  - 123 (A) the minor's death; or
  - (B) a serious risk of substantial and irreversible impairment of a major bodily function
  - of the minor; and
  - (ii) there is not sufficient time to give the notice required under Subsection (3) before it
  - is necessary to terminate the minor's pregnancy in order to avert the minor's death or

  - 132  $\hat{H} \rightarrow [\underline{\text{(ii)}}] (\underline{B}) \leftarrow \hat{H}$  the parent or guardian has abused the minor;  $\{\underline{\text{or}}\}$
  - (c) subject to Subsection (5)(b), the parent or guardian has not assumed responsibility

  - (i) enters an order under Subsection 76-7-304.5(5)(b); and
