38	(a) "Division" means the Division of Water Resources created in Section 73-10-18.						
39	(b) "State agency" means an executive, legislative, or judicial branch department,						
40	agency, board, commission, or division, including a state institution of higher education as						
41	defined in Section 53B-3-102.						
42	(c) (i) "State facility" means a building, structure, or other improvement that is						
43	constructed on property owned by the state or a state agency.
