- 2. *Page 2, Lines 33 through 37:* 
  - 33 (1) (a) "Building," in addition to its ordinary meaning, means any watercraft, aircraft,
  - trailer {, sleeping car}, or other structure or vehicle adapted for overnight accommodation of
  - persons or for carrying on business therein and includes:
  - 36 { (a) Each } (i) each separately secured or occupied portion of the structure or vehicle; and
  - 37 { (b) Each } (ii) each structure appurtenant to or connected with the structure or vehicle.
    - (b) "Building" does not include a railroad car.
- 3. *Page 2, Lines 47 through 48:* 
  - 47 (5) (a) "Railroad car," in addition to its ordinary meaning, includes a sleeping car or any container or trailer
  - 48 that is on a railroad car.

  - 205 <u>conviction for a violation of this section,</u> if the charge has been subsequently reduced or
