H.B. 161 Corporate Franchise and Income Tax Credits Relating to Biodiesel or Syngas Production (*Rep. M. Noel*)

MOTION: Rep. Barrus moved to delete in title and body H.B. 161 and replace it with 2nd Substitute H.B. 161. The motion passed unanimously with Rep. Cosgrove, Rep. Harper, Rep. Hughes, and Rep. Johnson absent for the vote.

Rep. Noel introduced the bill and explained it to the committee.

MOTION: Rep. Wimmer moved to transmit the bill with a favorable recommendation. The

S.B. 260 Property Tax - Definition of Goodwill (Sen. W. Niederhauser) (Rep. C. Frank)

Rep. Dougall assisted by Mark Buchi, Tax Review Commission, introduced the bill and explained it to the committee. Sen. Niederhauser assisted in answering questions. Commissioner Mark Johnson, Utah State Tax Commission spoke in favor of the bill.

MOTION: Rep. Dougall moved to transmit SB260 with a favorable recommendation. The motion passed unanimously with Rep. Harper absent for the vote.

MOTION: Rep. Dougall moved that SB 260 be placed on the consent calendar. The motion passed unanimously with Rep. Harper absent for the vote.

MOTION: Rep. Dougall moved to saunter for two minutes. The motion passed by voice vote.

1st Sub. S.B. 13Tax Credits for Alternate Power Generation (Sen. H. Stephenson)
(Rep. M. Noel)

MOTION: Rep. Dougall moved to substitute in title and body 1st Sub. S.B. 13 and replace it with 3rd Substitute S.B. 13, Tax Incentives for Alternate Power Generation, and to amend the bill as follows:

- 1. Page 5, Lines 119 through 125:
 - 119 (iii) If a business entity sells a residential unit to an individual taxpayer before making
 - 120 <u>a claim for the tax credit under this Subsection (2)(a), the business entity may:</u>
 - 121 (A) assign its right { to this tax credit } to the individual taxpayer; and
 - 122 (B) if the business entity assigns its right { to the tax credit } to an individual taxpayer
 - 123 <u>under Subsection (2)(a)(iii)(A)</u>, the individual taxpayer may claim the {<u>tax credit as if</u> the
 - 124 <u>individual taxpayer had completed or participated in the costs of the residential</u> <u>energy system</u>
 - 125 <u>under Section 59-10-1014</u>} <u>payment allowed by Section 59-12-104.6</u>.

The motion passed unanimously with Rep. Harper, Rep. Hughes, Rep. McGee, and Rep. Newbold absent for the vote.

Rep. Noel and Sen. Stephenson assisted by Shelly Cordon-Teuscher, UPC Wind, introduced the
