5. <u>S.B. 200 Reduced Cigarette Ignition Propensity</u> (E. Mayne)

- 61 <u>(a) any entity which:</u>
- 62 <u>(i) manufactures or otherwise produces cigarettes to be sold in the state;</u>
- 63 <u>(ii) causes cigarettes to be manufactured or produced anywhere with the intent</u> to sell in
- 64 <u>the state; or</u>
- 65 <u>(iii) manufactures or otherwise produces cigarettes or cause cigarettes to be</u>
- 66 <u>manufactured or produced with the intent to sell in the United States through an</u> <u>importer;</u>
- 67 <u>(b) the first purchaser anywhere that intends to resell in the United States</u> cigarettes
- 68 <u>manufactured anywhere that the original manufacturer or maker does not intend to</u> <u>be sold in</u>
- 69 <u>the United States; or</u>
- 70 <u>(c) any entity that becomes a successor of an entity described in Subsection</u> (3)(a) or
- 71 <u>(3)(b).</u>}

The motion passed unanimously with Sen. Knudson absent for the vote.

Andrew McGuire, National Fire Protection Assn., spoke in support of the bill.

MOTION: Sen. Goodfellow moved to pass the bill out favorably as amended.

The motion passed unanimously with Sen. Knudson absent for the vote.

6. <u>S.B. 189 Medicaid Home and Community-based Long-Term Care</u> (G. Davis)

Sen. Davis explained the bill.

Michael Hales, Director, Division of Health Care Financing, Department of Health, spoke in support of the bill.

MOTION: Sen. Goodfellow moved to pass the bill out favorably.
