**ANIMAL CRUELTY REVISIONS**

**LONG TITLE**

**General Description:**

This bill modifies the Criminal Code regarding animal cruelty by providing that torture of an animal is a felony. This bill amends references to criminal intent and amends certain definitions.

**Highlighted Provisions:**

This bill:

- ▶ amends the definition of necessary food, care, and shelter to include water and shelter as appropriate to the animal and moves the definitions to the beginning of the section;
- ▶ clarifies the general applicability of the exemption for acting under a legal privilege;
- ▶ provides an exemption for animals kept and used for training hunting dogs and falcons and also for animals kept or owned by a zoological park;
- ▶ includes the offense of seriously injuring an animal;
- ▶ provides that the court shall state on the record the reasons a person convicted of animal cruelty is not required to receive treatment, pay restitution, or to not have possession of animals for a specified period;
- ▶ provides an exemption regarding torture if the animals are used for agricultural purposes;



26           ▶ provides that after the first priority of placing the animal through adoption, the  
27 option of offering the animal for sale at auction precedes the option of euthanasia;  
28 and

29           ▶ amends the definition of conviction to include pleas in abeyance or of nolo  
30 contendere.

45           Section 1. Section **76-3-203.3** is amended to read:

46           **76-3-203.3. Penalty for hate crimes -- Civil rights violation.**

47           As used in this section:

48           (1) "Primary offense" means those offenses provided in Subsection (4).

49           (2) (a) A person who commits any primary offense with the intent to intimidate or  
50 terrorize another person or with reason to believe that his action would intimidate or terrorize  
51 that person is subject to Subsection (2)(b).

52           (b) (i) A class C misdemeanor primary offense is a class B misdemeanor; and

53           (ii) a class B misdemeanor primary offense is a class A misdemeanor.

54           (3) "Intimidate or terrorize" means an act which causes the person to fear for his  
55 physical safety or damages the property of that person or another. The act must be  
56 accompanied with the intent to cause or has the effect of causing a person to reasonably fear to

57 freely exercise or enjoy any right secured by the Constitution or laws of the state or by the  
58 Constitution or laws of the United States.

78 Section 2. Section **76-9-301** is amended to read:

79 **76-9-301. Cruelty to animals.**

80 (1) As used in this section:

81 (a) "Abandon" means to deposit, leave, or drop off any live animal:

82 (i) without providing for the care of that animal; or

83 (ii) in a situation where conditions present an immediate, direct, and serious threat to  
84 the life, safety, or health of the animal.

85 (b) (i) "Animal" means a live, nonhuman, vertebrate creature.

86 (ii) "Animal" does not include:

87 (A) animals owned, kept, managed, or used for agricultural purposes and cared for in

88 accordance with accepted husbandry practices, including animals kept or owned for  
89 agricultural purposes as part of a small farm or activity that is operated without expectation of  
90 its being a primary source of income;

91 (B) animals used for rodeo purposes and cared for in accordance with accepted  
92 husbandry practices;

93 (C) animals kept or owned by a zoological park that is:

94 (I) accredited by the American Zoo and Aquarium Association and cared for in  
95 accordance with accepted husbandry practices; or

96 (II) owned or operated by a member of the American Zoo and Aquarium Association  
97 and cared for in accordance with accepted husbandry practices;

98 (D) wildlife, as defined in Section 23-13-2, including protected and unprotected  
99 wildlife; and

100 (E) animals kept or owned for the purpose of training hunting dogs or raptors and cared

118 privilege to do so, intentionally, knowingly, recklessly, or with criminal negligence:

- 119 (a) fails to provide necessary food, water, care, or shelter for an animal in his custody;
- 120 (b) abandons an animal in the person's custody;
- 121 (c) transports or confines an animal in a cruel manner;
- 122 (d) injures an animal;
- 123 (e) causes any animal, not including a dog, to fight with another animal of like kind for
- 124 amusement or gain; or

131 having legal privilege to do so:

- 132 [~~(a) tortures an animal;~~]
- 133 [~~(b)~~] (a) (i) administers or causes to be administered poison or poisonous substances to
- 134 an animal [~~without having a legal privilege to do so~~]; or

145 (6) (a) A person is guilty of felony animal cruelty if a person tortures an animal,

146 including if the person causes the animal's death by torture.

148 (c) This Subsection (6) does not apply to an animal owned, kept, managed, or used for

149 agricultural purposes, if the actor owns the animal or has lawful authority to keep, manage, or

150 use the animal.

151 [(5)] (7) It is a defense to prosecution under this section that the conduct of the actor  
152 towards the animal was:

153 (a) by a licensed veterinarian using accepted veterinary practice;

154 (b) directly related to bona fide experimentation for scientific research, provided that if  
155 the animal is to be destroyed, the manner employed will not be unnecessarily cruel unless  
156 directly necessary to the veterinary purpose or scientific research involved;

157 (c) permitted under Section 18-1-3, which permits killing or injuring a dog under  
158 certain circumstances;

159 (d) by a person who humanely destroys any animal found suffering past recovery for  
160 any useful purpose; or

161 (e) by a person who humanely destroys any apparently abandoned animal found on the  
162 person's property.

163 [(6)] (8) For purposes of Subsection [(5)] (7)(d), before destroying the suffering  
164 animal, the person who is not the owner of the animal shall obtain:

165 (a) the judgment of a veterinarian of the animal's nonrecoverable condition;

166 (b) the judgment of two other persons called by the person to view the unrecoverable  
167 condition of the animal in the person's presence;

168 (c) the consent from the owner of the animal to the destruction of the animal; or

169 (d) a reasonable conclusion that the animal's suffering is beyond recovery, through the  
170 person's own observation, if the person is in a location or circumstance where the person is  
171 unable to contact another person.

172 [(7)] (9) This section does not affect or prohibit the training, instruction, and grooming  
173 of animals, so long as the methods used are in accordance with accepted husbandry practices.

174 [(8)] (10) (a) This section does not affect or prohibit the use of an electronic locating or  
175 training collar by the owner of an animal for the purpose of lawful animal training, lawful  
176 hunting practices, or protecting against loss of that animal.

177 (b) County and municipal governments may not prohibit the use of an electronic  
178 locating or training collar.

179 [(9)] (11) (a) Upon conviction under this section, the court [~~may in its discretion, in~~  
180 ~~addition to other~~] may:

181 (i) order that the defendant comply with the requirements in Subsections (11)(b) and  
182 (c) ; and  
183 (ii) impose any additional penalties[;] as the court finds appropriate to the case before

224 **76-9-301.5. Spectator at organized animal fighting exhibitions -- Penalty.**

225 (1) It is unlawful for a person to knowingly be present as a spectator at any place,  
226 building, or tenement where preparations are being made for an exhibition of the fighting of  
227 animals, as prohibited by [Subsection] Subsections 76-9-301[(+)](2)(e) and (f), or to be present  
228 at [such] an exhibition, regardless of whether any entrance fee has been charged.

229 (2) A person who violates [this subsection] Subsection (1) is guilty of a class B  
230 misdemeanor.

231 Section 4. Section **76-9-301.6** is amended to read:

232 **76-9-301.6. Dog fighting exhibition -- Authority to arrest and take possession of**  
233 **dogs and property.**

234 (1) A peace officer, as defined in Title 53, Chapter 13, Peace Officer Classifications,  
235 may enter any place, building, or tenement where an exhibition of dog fighting is occurring, or  
236 where preparations are being made for [such] an exhibition and, without a warrant, arrest all  
237 persons present.

238 (2) (a) Notwithstanding the provisions of Section 76-9-305, any authorized officer who  
239 makes an arrest under Subsection (1) may lawfully take possession of all dogs, paraphernalia,  
240 implements, or other property or things used or employed, or to be employed, in an exhibition  
241 of dog fighting prohibited by Subsection 76-9-301[(+)](2)(f) or Section 76-9-301.1.

242 (b) The officer, at the time of the taking of property pursuant to Subsection (2)(a), shall



243 state his name and provide other identifying information to the person in charge of the dogs or  
244 property taken.

245 (3) (a) After taking possession of dogs, paraphernalia, implements, or other property or  
246 things under Subsection (2), the officer shall file an affidavit with the judge or magistrate  
247 before whom a complaint has been made against any person arrested under this section.

248 (b) The affidavit shall include:

249 (i) the name of the person charged in the complaint;

250 (ii) a description of all property taken;

251 (iii) the time and place of the taking of the property;

252 (iv) the name of the person from whom the property was taken;

271 ill, or no contest, or a verdict[:] of guilty; and

272 (b) includes a plea that is held in abeyance under Title 77, Chapter 2a, Pleas in  
273 Abeyance, even if the charge has been subsequently reduced or dismissed in accordance with

274 the plea in abeyance agreement.

275 (2) A person who commits any violation of Section 76-9-301, Section 76-9-301.5, or

297 As used in this part:

298 (1) "Enterprise" means any individual, sole proprietorship, partnership, corporation,  
299 business trust, association, or other legal entity, and any union or group of individuals  
300 associated in fact although not a legal entity, and includes illicit as well as licit entities.

301 (2) "Pattern of unlawful activity" means engaging in conduct which constitutes the  
302 commission of at least three episodes of unlawful activity, which episodes are not isolated, but  
303 have the same or similar purposes, results, participants, victims, or methods of commission, or  
304 otherwise are interrelated by distinguishing characteristics. Taken together, the episodes shall

305 demonstrate continuing unlawful conduct and be related either to each other or to the
