## Mr. Speaker:

The Business and Labor Committee reports a favorable recommendation on **H.B. 342**, INSURANCE CODE AMENDMENTS, by Representative J. Dunnigan, with the following amendments:

1. Page 52, Lines 1582 through 1584: 1582 (4)  $\{ \underline{\mathbf{A}} \}$ Except for a bank, savings and loan association, industrial bank, or credit union, a service contract provider may not sell, or be the obligated party for: 1583 (a) a guaranteed asset protection waiver; { or }

- 3. Page 72, Lines 2224 through 2226:
  - 2224 (3) (a) The department may [request:] require a person applying for a license { , for 2225 renewal of a license, } or for consent to engage in the business of insurance to submit to a
  - 2226 <u>criminal background check as a condition of receiving a license</u> { , renewal, } <u>or consent.</u>
- 4. Page 81, Lines 2486 through 2488:
  - 2486 (4) (a) The department may require a person applying for a license (5, for renewal)
  - 2487 <u>license</u>, or for consent to engage in the business of insurance to submit to a criminal
  - 2488 <u>background check as a condition of receiving a license</u> { <u>, renewal,</u> } <u>or consent.</u>
- 5. Page 83, Lines 2557 through 2559:
  - 2557 (3) (a) The department may require a person applying for a license {, for renewal of a
  - 2558 license, or for consent to engage in the business of insurance to submit to a criminal
  - 2559 <u>background check as a condition of receiving a license</u> { <u>, renewal,</u> } <u>or consent.</u>
