Rep. Painter, Vice Chair, called the meeting to order at 8:13 a.m.

MOTION: Rep. Shurtliff moved to adopt the minutes of February 5, 2008. The motion passed unanimously. Rep. Anderson, Rep. Last, Rep. Moss, Rep. Urguhart, and Rep. Hughes were absent for the vote.

Community Council Elections (Rep. K. Sumsion) 1st Sub. H.B. 127

MOTION: Rep. Sumsion moved to delete in title and body 1st Substitute H.B. 127 and adopt 2nd Substitute H.B. 127. The motion passed unanimously. Rep. Anderson, Rep. Last, Rep. Moss, and Rep. Urguhart were absent for the vote.

Rep. Sumsion introduced the bill which amends provisions for the election of school community councils.

MOTION: Rep. Shurtliff moved to pass the bill out with a favorable recommendation. The motion passed unanimously. Rep. Last, Rep. Moss, and Rep. Urquhart were absent for the vote.

MOTION: Rep. Frank moved to place the bill on the Consent Calendar. The motion failed with Rep. Holdaway and Rep. Shurtliff voting in opposition. Rep. Last, Rep. Moss, and Rep. Urquhart were absent for the vote.

H.B. 254 School Community Council Amendments (Rep. R. Menlove)

MOTION: Rep. Newbold moved to delete in title and body H.B. 254 and adopt 1st Substitute H.B. 254. The motion passed unanimously. Rep. Last, Rep. Moss, and Rep. Urquhart were absent for the vote.

Rep. Menlove introduced the bill which modifies provisions regarding the term of office of school community council members.

Keith Davis, Principal, Grantsville Junior High School, spoke in support of the bill.

MOTION: Rep. Hughes moved to pass the bill out with a favorable recommendation. The motion passed unanimously. Rep. Moss and Rep. Urquhart were absent for the vote.

H.B. 189 School Community Councils (Rep. R. Bigelow)

MOTION: Rep. Lockhart moved to amend the bill as follows:

- 1. Page 4, Lines 109 through 117:
 - 109 (7) (a) A school community council shall provide the following information:
 - (i) the proposed school community council meeting schedule for the year, provided
 - during the first two weeks of the school year;
 - 112 (ii) a summary of the school community council's actions and activities during the first
 - half of the school year information, provided at the mid-point of the school year; and
 - (iii) a summary of the annual report required under Section 53A-16-101.5 on how the
 - school's School LAND Trust Program monies were used to enhance or improve academic
 - excellence at the school and implement a component of the school's improvement plan,

117 <u>provided at the</u> {<u>conclusion</u>} <u>beginning</u> <u>of the</u> <u>next</u> <u>school year.</u>

The motion passed unanimously. Rep. Moss and Rep. Urquhart were absent for the vote.

Rep. Bigelow introduced the bill which requires a school community council to provide certain information to school households.

H.B. 330 State Supplemental Funding for Head Start (Rep. L. Shurtliff)

Rep. Shurtliff moved to delete in title and body H.B. 330 and adopt 1st Substitute H.B. 330. The motion passed unanimously. Rep. Frank and Rep. Newbold were absent for the vote.

Rep. Shurtliff introduced the bill which establishes state supplemental funding for Head Start programs in Utah.
