LONG TITLE

This bill creates the Snake Valley Aquifer Research Team and Advisory Council.

36 Section 1. Section **63C-12-101** is enacted to read:

37 **CHAPTER 12. SNAKE VALLEY AQUIFER ADVISORY COUNCIL**

38 **63C-12-101. Title.**

39 This chapter is known as the "Snake Valley Aquifer Advisory Council."

40 Section 2. Section **63C-12-102** is enacted to read:

41 **63C-12-102. Definitions.**

42 As used in this chapter:

43 (1) "Council" means the Snake Valley Aquifer Advisory Council created in Section
44 63C-12-103.

45 (2) "Research team" means the Snake Valley Research Team created in Section
46 63C-12-107.

47 Section 3. Section **63C-12-103** is enacted to read:

48 **63C-12-103. Council creation -- Members -- Terms.**

49 (1) There is created a state advisory council known as the "Snake Valley Aquifer
50 Advisory Council."

51 (2) The advisory council is composed of the following six members:

52 (a) the governor or the governor's designee; and

53 (b) five members appointed by the governor as follows:

54 (i) two county commissioners, from individuals recommended by an organization that
55 represents counties in the state, who are residents of:

56 (A) Tooele County;

- 57 (B) Juab County;
58 (C) Millard County; or
59 (D) Beaver County;
60 (ii) two residents of:
61 (A) Tooele County;
62 (B) Juab County;
63 (C) Millard County; or
64 (D) Beaver County; and
65 (iii) a representative of the Confederate Tribes of Goshute Reservation.
66 (3) A member appointed under Subsection (2)(b) is appointed to a two-year term.
67 (4) Notwithstanding the requirements of Subsection (3), the governor shall, at the time
68 of appointment or reappointment, adjust the length of terms to ensure that the terms of council
69 members appointed under Subsection (2)(b) are staggered so that approximately half of the
70 council is appointed every two years.
71 (5) The governor shall appoint a chairperson.
72 (6) If a vacancy occurs in council membership for any reason the replacement shall be
73 appointed for the unexpired term in the same manner as the vacated member was appointed.
74 Section 4. Section **63C-12-104** is enacted to read:
75 **63C-12-104. Advisory council duties -- Meetings.**
76 (1) The council shall:
77 (a) meet at least annually but may also meet at the call of:
78 (i) the chair; or
79 (ii) at least two council members;
80 (b) provide advice to the research team, including recommendations concerning the
81 type of data and information gathered by the research team;
82 (c) review the data and information gathered and reported by the research team,
83 including baseline data and changes from baseline data; and
84 (d) act as liaison between the research team and the persons represented by the council.
85 (2) A majority of the council members constitute a quorum for the transaction of
86 council business.
87 (3) The council may advise the governor and the Legislature on any issue relating to its

88 review under Subsection (1)(c).

89 Section 5. Section **63C-12-105** is enacted to read:

90 **63C-12-105. Compensation of members -- Expenses.**

91 (1) This section applies to members of the council.

92 (2) (a) A member who is not a government employee may not receive compensation or
93 benefits for the member's service, but may receive per diem and expenses incurred in the
94 performance of the member's official duties at the rates established by the Division of Finance
95 under Sections 63A-3-106 and 63A-3-107.

96 (b) A member may decline to receive per diem and expenses for the member's service.

97 (3) (a) A state government officer and employee member who does not receive salary,
98 per diem, or expenses from the agency the member represents for the member's service may
99 receive per diem and expenses incurred in the performance of the member's official duties at
100 the rates established by the Division of Finance under Sections 63A-3-106 and 63A-3-107.

101 (b) A state government officer and employee member may decline to receive per diem
102 and expenses for the member's service.

103 (4) (a) A local government member who does not receive salary, per diem, or expenses
104 from the entity that the member represents for the member's service may receive per diem and
105 expenses incurred in the performance of the member's official duties at the rates established by
106 the Division of Finance under Sections 63A-3-106 and 63A-3-107.

107 (b) A local government member may decline to receive per diem and expenses for the
108 member's service.

109 Section 6. Section **63C-12-106** is enacted to read:

110 **63C-12-106. Staff.**

111 The director of the Public Lands Policy Coordinating Office shall provide staff services
112 to the council.

113 Section 7. Section **63C-12-107** is enacted to read:

114 **63C-12-107. Research team.**

115 (1) There is created a Snake Valley Aquifer Research Team composed of the following
116 four members:

117 (a) a representative of the Division of Air Quality, appointed by the executive director
118 of the Department of Environmental Quality;

119 (b) a representative of the Department of Agriculture and Food, appointed by the
120 commissioner of the Department of Agriculture and Food;

121 (c) the executive director of the Department of Natural Resources or the executive
122 director's designee; and

123 (d) the director of the Public Lands Policy Coordinating Office.

124 (2) The director of the Public Lands Policy Coordinating Office shall coordinate and
125 direct the research team's data and information compilation, evaluation, and reporting required
126 by Section 63C-12-108.

127 Section 8. Section **63C-12-108** is enacted to read:

128 **63C-12-108. Research team duties.**

129 The research team shall:

130 (1) compile existing scientific research data on and evaluate the potential impact of the
131 use of water resources in the interstate groundwater flow system specified in the Lincoln
132 County Conservation, Recreation, and Development Act of 2004, Pub. L. No. 108-424,
133 including the impact on:

134 (a) surface water and groundwater;

135 (b) vegetation, including invasive species;

136 (c) agriculture;

137 (d) soils;

138 (e) air quality;

139 (f) wildlife;

140 (g) the geologic integrity of the aquifer; and

141 (h) socioeconomic conditions;

142 (2) compile baseline data and changes to the baseline data and information for the
143 evaluation required under Subsection (1);

144 (3) seek to enter into cooperative agreements with governmental entities to share
145 relevant data and information;

146 (4) provide an annual data and information report to the council; and

147 (5) seek the voluntary participation of experts in academia and the private sector in the
148 activities of the research team.

149 Section 9. Section **63J-4-603** is amended to read:

150 **63J-4-603. Powers and duties of coordinator and office.**
151 (1) The coordinator and the office shall:
152 (a) assist the state planning coordinator in fulfilling the duties outlined in Section
153 63J-4-401 as those duties relate to the development of public lands policies by:
154 (i) developing cooperative contracts and agreements between the state, political
155 subdivisions, and agencies of the federal government for involvement in the development of
156 public lands policies;
157 (ii) producing research, documents, maps, studies, analysis, or other information that
158 supports the state's participation in the development of public lands policy;
159 (iii) preparing comments to ensure that the positions of the state and political
160 subdivisions are considered in the development of public lands policy;
161 (iv) partnering with state agencies and political subdivisions in an effort to:
162 (A) prepare coordinated public lands policies;
163 (B) develop consistency reviews and responses to public lands policies;
164 (C) develop management plans that relate to public lands policies; and
165 (D) develop and maintain a statewide land use plan that is based on cooperation and in
166 conjunction with political subdivisions; and
167 (v) providing other information or services related to public lands policies as requested
168 by the state planning coordinator; [~~and~~]
169 (b) facilitate and coordinate the exchange of information, comments, and
170 recommendations on public lands policies between and among:
171 (i) state agencies;
172 (ii) political subdivisions;
173 (iii) the Office of Rural Development created under Section 63M-1-1602;
174 (iv) the Resource Development Coordinating Committee created under Section
175 63J-4-501;
176 (v) School and Institutional Trust Lands Administration created under Section
177 53C-1-201;
178 (vi) the committee created under Section 63F-1-508 to award grants to counties to
179 inventory and map R.S. 2477 rights-of-way, associated structures, and other features; and
180 (vii) the Constitutional Defense Council created under Section 63C-4-101;

181 (c) perform the duties established in Title 9, Chapter 8, Part 3, Antiquities, and Title 9,
182 Chapter 8, Part 4, Historic Sites; [~~and~~]

183 (d) consistent with other statutory duties, encourage agencies to responsibly preserve
184 archaeological resources[-];

185 (e) provide staff services to the Snake Valley Aquifer Council created in Section
186 63C-12-103; and

187 (f) coordinate and direct the Snake Valley Research Team created in Section
188 63C-12-107.

189 (2) In providing assistance to the state planning coordinator under Subsection (1)(a),
190 the coordinator and office shall take into consideration the:

191 (a) findings provided under Subsections 63J-4-401(6) and (7); and

192 (b) recommendations of the council.
