This joint resolution of the Legislature addresses renewable energy systems.
Highlighted Provisions:
This resolution:
<ul> <li>directs the State Energy Program to assess the need for model wind, solar, and</li> </ul>
geothermal ordinances at the local government level and to report to the Legislature
on its process for assessing the need;
<ul> <li>directs the State Energy Program to help develop model ordinances for renewable</li> </ul>
energy; and
<ul> <li>directs that a copy of the resolution be sent to the State Energy Program.</li> </ul>
Special Clauses:
None
Be it resolved by the Legislature of the state of Utah:
WHEREAS, the state has established a target of 20 percent renewable energy electricity
generation by the year 2025;

WHEREAS, it is the policy of the state to encourage the development of independent

26	and qualifying power production and cogeneration facilities, to promote a diverse array of
27	economical and sustainable energy resources in an environmentally acceptable manner, and to
28	conserve our finite and expensive energy resources and provide for their most efficient and
29	economic utilization;
30	WHEREAS, the state wishes to provide clarity to the process of developing renewable
31	energy projects and to reduce the bureaucratic and permitting burden for Utah residents,
32	businesses, and local governments in developing renewable energy;
33	WHEREAS, the state finds that wind, geothermal, and solar energy are abundant,
34	renewable, and non-polluting energy resources;
35	WHEREAS, wind, geothermal, and solar energy systems can help to offset growing
36	energy and peak power demands;
37	WHEREAS, the state wishes to advance the use of wind, geothermal, and solar energy
38	by all of its citizens, businesses, and industries;
39	WHEREAS, properly designed renewable energy installation ordinances can help
40	communities facilitate greater access to wind, geothermal, and solar energy;
41	WHEREAS, it is the goal of the state to develop wind, geothermal, and solar power,
42	while preserving farmlands and agricultural enterprises and adjoining residential and
43	commercial developments as compatible adjoining uses, and the public health, safety, and
44	general welfare will be protected and promoted by this ordinance;
45	WHEREAS, the state recognizes that the renewable energy industry is growing and can
46	continue to benefit the state economically, and efforts to streamline renewable energy
47	installations encourages economic development in the state;
48	WHEREAS, solar working groups meet quarterly throughout the state as administered
49	by the State Energy Program; and
50	WHEREAS, geothermal working groups meet annually throughout the state as
51	administered by the State Energy Program:
52	NOW, THEREFORE, BE IT RESOLVED that the State Energy Program be directed to
53	assess the need for a model solar ordinance through a consensus building stakeholder process
54	to include, if considered useful, the development of a model solar ordinance.
55	BE IT FURTHER RESOLVED that the State Energy Program be directed to report the
56	findings of the consensus building stakeholder process and any resulting model solar ordinance

57	to the Legislature no later than November 30, 2009.
58	BE IT FURTHER RESOLVED that the State Energy Program be directed to assess the
59	need for a geothermal ordinance through a consensus building stakeholder process to include,
60	if considered useful, the development of a model geothermal ordinance.
61	BE IT FURTHER RESOLVED that the State Energy Program be directed to report the
62	findings of the consensus building stakeholder process to the Legislature no later than
63	November 30, 2009.
64	BE IT FURTHER RESOLVED that a copy of this joint resolution be sent to the State
65	Energy Program.
66	BE IT FURTHER RESOLVED that the State Energy Program be directed to consult
67	and work cooperatively with representatives of municipal governments and other interested
68	parties to develop model ordinances relating to wind and other renewable energy for
69	municipalities to consider adopting as they consider appropriate for their jurisdictions.
