31	(b) In accordance with Title 63G, Chapter 3, Utah Administrative Rulemaking Act,
32	the division may make rules necessary to implement [the provisions of] this chapter.
33	(2) By acting as an athlete agent in this state, a nonresident individual appoints the
34	director of the division as the individual's agent for service of process in any civil action in
35	this state related to the individual's acting as an athlete agent in this state.
36	[(3) (a) There is created the Athlete Agents Licensing Board consisting of four athlete
37	agents and one member of the general public.]
38	[(b) The Athlete Agents Licensing Board shall be appointed and serve in accordance
