Mr. President:

The Business and Labor Committee reports a favorable recommendation on **S.B. 279**, IDENTITY FRAUD AND RELATED AMENDMENTS, by Senator S. Urquhart, with the following amendments:

- 1. Page 1, Line 9:
  - 9 This bill modifies { the Utah Workforce Services Code and } the Utah Criminal Code to
- 2. Page 1, Line 13:
  - 13 { → addresses the new hire registry; }
- 3. Page 1, Line 24:
  - 24 {<del>35A-7-107, as last amended by Laws of Utah 2008, Chapter 382</del>}
- 4. Page 2, Lines 28 through 50:
  - { 28 Section 1. Section 35A-7-107 is amended to read:
    - 29 <u>35A-7-107. Use and access to the registry records.</u>
    - 30 (1) (a) The records of the registry shall be maintained as private records under Section
    - 31 <del>63G-2-202.</del>

- 32 (b) In addition to those persons granted access to private records under Sections
- 33 63G-2-202 and 63G-2-206, state or federal agencies may access data from the registry for the
- 34 following purposes:
- 35 (i) the Office of Recovery Services for use related to locating, establishing, and
- 36 enforcing child, medical, and spousal support obligations and other services;
- 37 (ii) state agencies [which] that use financial information in determining eligibility for
- 38 public assistance programs; and
- 39 (iii) federal agencies responsible for periodic matches of new hire registry information
- 40 with federal data bases.
- 41 (2) Information that is received under this chapter shall be kept by the department for at
- 42 least six months.
- 43 (3) (a) As used in this Subsection (3), "personal identifying information" has the same
- 44 <u>meaning as defined in Section 76-6-1102.</u>
- 45 (b) Notwithstanding Section 35A-4-312 and the other provisions of this section, if the
- 46 <u>registry records disclose a suspected misuse of personal identifying information by an</u>
- 47 <u>individual other than the purported owner of the information, the department may:</u>
- 48 (i) inform an employer of the suspected misuse; and
- 49 <u>(ii) provide information of the suspected misuse to an appropriate law enforcement</u>
- 50 <u>agency responsible for investigating an identity fraud violation.</u> }
