MOTION: Rep. Gibson moved to transmit H.B. 45 as amended with a favorable recommendation. The motion passed with Rep. Biskupski, Rep. Duckworth, and Rep. Hansen voting in opposition and Rep. Froerer and Rep. Garn absent for the vote.

H.B. 73 Utah Construction Trades Continuing Education Amendments (*Rep. M. Morley*)

Rep. Morley introduced the bill and explained it to the committee. Mark Steinagel, Director, Division of Occupational and Professional Licensing; John Hill, Rocky Mountain Gas Association; and Taz Biesinger, Utah Home Builders' Association, spoke in favor of the bill. Larry Facer, Plumbers Local 140, spoke to the bill, and Dan Jones, Division of Occupational and Professional Licensing, responded to questions from the committee.

MOTION: Rep. Gibson moved to transmit H.B. 73 with a favorable recommendation. The motion passed unanimously with Rep. Froerer and Rep. Garn absent for the vote.

H.B. 11 Licensing of Elevator Contractors and Elevator Mechanics (*Rep. L. Wiley*)

MOTION: Rep. Hansen moved to amend H.B. 11 as follows:

 - 114 (14) "Elevator" has the same meaning as defined in Section 34A-7-202 , except that for purposes of this chapter it does not mean a stair chair, a vertical platform lift, or an incline platform lift .
