**MOTION:** Rep. Hansen moved to approve the minutes of the Feb 26, 2010 meeting. The motion passed unanimously with Rep. Clark, Rep. Gibson, and Rep. Painter absent for the vote.

H.B. 408 Hospital Claims Management (*Rep. B. Last*)

**MOTION:** Rep. Webb moved to replace H.B. 408 with 1st Substitute H.B. 408. The motion passed unanimously with Rep. Clark, Rep. Gibson, Rep. Morley, and Rep. Painter absent for the vote.

**MOTION:** Rep. Kiser moved to amend 1st Sub. H.B. 408 as follows:

- 1. Page 2, Lines 39 through 41:
  - 39 (ii) the method for implementation and evaluation of an open and honest dialogue
  - 40 <u>between a health care provider and a patient</u>, {<u>or</u>} <u>and</u> <u>the patient's</u> representative, after an
  - 41 <u>unanticipated event resulting from medical care provided to the patient.</u>

H.J.R. 34 Joint Resolution on Hospital Claims Management (*Rep. B. Last*)

Rep. Last, assisted by Lieutenant Governor Bell and John T. Nielson from the Governor's Office, introduced the resolution and explained it to the committee.

**MOTION:** Rep. Kiser moved to transmit 1st Sub. H.J.R. 34 with a favorable recommendation. The motion passed with Rep. Hansen voting in opposition.

H.B. 421 Medical Financial Records Amendments (*Rep. B. Last*)

Rep. Last introduced the bill and explained it to the committee aided by Spencer Stokes of Stokes Strategies.

**MOTION:** Rep. Gibson moved to transmit H.B. 421 with a favorable recommendation. The motion passed with Rep. Hansen voting in opposition.

H.C.R. 16 Statue of Responsibility Monument Concurrent Resolution (*Rep. M. Morley*)

Rep. Morley, assisted by Daniel Bolz, Statue of Responsibility Foundation, explained the resolution to the committee.

**MOTION:** Rep. King moved to transmit H.C.R. 16 with a favorable recommendation. The motion passed with Rep. Biskupski voting in opposition.

H.B. 399 Common Interest Ownership Amendments (*Rep. G. Froerer*)

H.B. 135 Pharmacy Benefit Managers Act (*Rep. E. Vickers*)

**MOTION:** Rep. Painter moved to amend H.B. 135 as follows:

- 1. Page 2, Line 29:
  - 29 ► prohibits {-relation-} <u>retaliation</u> by a pharmacy benefit manager under certain circumstances; and

The motion passed unanimously with Rep. Morley absent for the vote.

Rep. Vickers distributed a handout and explained the bill to the committee.

**MOTION:** Rep. Gibson moved to return H.B. 135 to rules for interim study. The motion passed unanimously with Rep. Morley absent for the vote.

**H.B. 320** Utah Construction Trades Licensing Act - Alarm Companies Amendments (*Rep. C. Herrod*)

**MOTION:** Rep. Painter moved to replace H.B. 320 with 1st Substitute H.B. 320. The motion passed unanimously with Rep. Morley absent for the vote.

Rep. Herrod introduced the bill and explained it to the committee. Mark Steinagel, Director, Division of Occupational and Professional Licensing, spoke to the bill.

MOTION: Rep. Gibson moved to amend 1st Sub. H.B. 320 as follows:

- 1. Page 2, Lines 27 through 33:
  - 27 58-55-302, an applicant for licensure as an alarm company agent may be issued:
  - 28 (a) an interim permit[-]; or
  - 29 (b) subject to Subsection (3), a temporary permit.
  - 30 (2) (a) Each interim <u>or temporary</u> permit shall expire 90 days after it is issued or on the date on
  - 31 which the applicant is issued a license, whichever is earlier.
  - 32 (b) The division may reissue an interim permit if the delay in approving a license is
  - 33 beyond the control or influence of the interim permit holder.

The motion passed unanimously with Rep. Morley absent for the vote.
